## MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS APRIL 17, 2017

The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, April 17, 2017, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Scott Langford. Having a duly constituted quorum, the meeting was opened in due process by Sheriff Sonny Weatherford. Chairman Langford noted that with twenty-four members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session.

#### APPROVAL OF AGENDA
