MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS SEPTEMBER 19, 2016

The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, September 19, 2016, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Pro Tem Trisha LeMarbre. Having a duly constituted quorum, the meeting was opened in due process by Sheriff Chief Deputy Aaron Pickard. Chairman Pro Tem Trisha LeMarbre noted that with twenty-two members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session. Commissioner Bill Taylor and Commission Chairman Scott Langford were not present for the meeting.

The Invocation was led by Stacey Durham, Creekview Church of Christ, Gallatin.

The Pledge of Allegiance was led by the County Clerk, Bill Kemp.

APPROVAL OF AGENDA

Commissioner Pomeroy moved, and was duly seconded by Commissioner Krueger, to adopt the agenda. The Commission approved the agenda by unanimous voice vote of the body.

APPROVAL OF MINUTES

The minutes for the meeting of this body held on August 15, 2016, and recorded in the office of the Clerk, Bill Kemp, were approved by voice vote after Commissioner Becker made the motion, seconded by Commissioner Ring. Commissioners Moe Taylor and Kemp abstained from the vote. Later in the meeting, Commissioner Krueger requested a correction to the minutes on Page 13 to show a vote by Commissioner Krueger against the 2016-2017 Commission committee slate. Without objection, Chairman Pro Tem LeMarbre declared the change made to the minutes.
