MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS JULY 17, 2017

The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, July 17, 2017, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Scott Langford. Also present were the County Clerk Bill Kemp, County Executive Anthony Holt and County Law Director Leah Dennen and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Sheriff Deputy Tim Bailey. Chairman Langford noted that with twenty-four members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session.

The Invocation was led by The Reverend Ken Shaw of the Trinity Lutheran Church.

The Pledge of Allegiance was led by the County Clerk, Bill Kemp.

APPROVAL OF AGENDA

Chairman Langford recognized Clerk Kemp who explained the procedures affected by the new voting board system.

Chairman Langford noted the amended agenda distributed to commissioners. The amended agenda included the election of Committees on Committees for 2017-2018.

Commissioner Chris Taylor moved to add a \$5,000.00 appropriation resolution to fund Walk Across Sumner to the agenda under the Financial Management Committee. Commissioner Foster seconded the motion and the Commission approved the addition by unanimous voice vote of the body. Commissioner Akins moved, and was duly seconded by Commissioner Krueger, to adopt the agenda with the addition. The Commission approved the agenda as amended by unanimous voice vote of the body.

APPROVAL OF MINUTES

The minutes for the meeting of this body held on June 19, 2017, and recorded in the office of the Clerk, Bill Kemp, were approved by voice vote after Commissioner Goode made the motion, seconded by Commissioner Ring.

RECOGNITION OF THE PUBLIC

Chairman Langford opened the floor to allow the public to speak concerning any matter on the agenda. With no one wishing to speak, recognition of the public was closed.

REPORT OF THE CHAIR

WHEREAS, Payton has signed a letter of intent to continue her stellar track and field career at Belmont University, becoming the first White House High School track athlete to receive a college scholarship for the sport.
