MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS OCTOBER 21, 2019

The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, October 21, 2019, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Scott Langford. Also present were the County Clerk Bill Kemp, County Mayor Anthony Holt and County Law Director Leah Dennen and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Chief Deputy Sheriff Aaron Pickard. Chairman Scott Langford noted that with twenty-four members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session.

The Invocation was led by Reverend Sean Stanfield, Rehoboth United Methodist Church.

The Pledge of Allegiance was led by the County Clerk, Bill Kemp.

APPROVAL OF AGENDA

Chairman Langford explained why an amended agenda was prepared to include Resolution 1910-16, approving the overall new courthouse construction project. Without objection, Chairman Langford added 1910-16 to the General Operations Committee report and a certificate of recognition to the Report of Chairman. Commissioner Mansfield called for a point of information pertaining to the Budget Committee practice of approving matters on a second reading. The ruling of Chairman Langford was that no second reading was necessary. Commissioner Foster moved, seconded by Commissioner Krueger, to adopt the amended agenda with the additions. The Commission approved the agenda as amended by voice vote of the body. Commissioner Mansfield abstained from the vote and Commissioner Moe Taylor voted against adoption of the agenda, stating his objection to the Chairman's ruling that a second approval does not apply.

APPROVAL OF MINUTES

The minutes for the meeting of this body held on September 16, 2019, and recorded in the office of the Clerk, Bill Kemp, were approved by voice vote after Commissioner Ring made the motion, seconded by Commissioner Echols.

Without objection, Chairman Langford moved Recognition of the Public below the Report of Chair. A report by Justice Planning Associates, LLC., was moved before Recognition of the Public, as well.

REPORT OF THE CHAIR

Commissioner Wright read the following resolution into the record:

A RESOLUTION HONORING SUMNER COUNTY ANTI-DRUG COALITION FOR ITS SUPPORT FOR C.H.A.M.P. CAMP

WHEREAS, Sumner County Sheriff's Office C.H.A.M.P. (Character, Honesty, Attitude, Motivation, Positivity) Camp is a week-long summer program for those students moving into the sixth, seventh, or eighth grades and who have also shown a positive attitude and a willingness to work with other students throughout the school year; and

WHEREAS, the C.H.A.M.P Camp is staffed by school resource officers who strive to bridge the gap between youth and law enforcement and teach students preventative measures and life skills which they can use at their homes or schools and the Sumner County Anti-Drug Coalition has been greatly instrumental in supporting this very important cause; and

WHEREAS, the Sumner County Anti-Drug Coalition has provided many valuable resources for the camp for the last three years and enabled school resource officers to form positive relationships with countless students since the camp's inception in 2017.

THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on this the 21st day of October 2019, that this body hereby recognizes and celebrates the Sumner County Anti-Drug Coalition for its contribution to make the C.H.A.M.P Camp the great success that it is today; and

BE IT FURTHER RESOLVED that this resolution is to be spread on the minutes of this body, and the Clerk is to furnish a copy of this resolution to the Sumner County Anti-Drug Coalition.

Upon motion by Commissioner Wright, seconded by Commissioner Foster, the Commission voted unanimously to approve the resolution recognizing the Sumner County Anti-Drug Coalition.

Chairman Langford introduced the following resolution into the record:

WHEREAS, Tennessee's 6.7 million residents rely on our 60,000 miles of rivers and streams, high quality aquifers, and groundwater along with our more than 100,000 miles of public water infrastructure to provide drinking water to greater than 90 percent of our state's population; and

WHEREAS, access to clean drinking water and managing water responsibly is critical to Tennessee communities' public and environmental health and to a high quality of life through economic commerce, power generation, and recreation; and

WHEREAS, the water and wastewater infrastructure that brings water to and from homes and businesses is essential to the quality of life and economic vitality of Tennessee; and

WHEREAS, utilities in urban, suburban, and rural Tennessee communities are grappling with aging infrastructure and access to the reliable funding required to maintain and upgrade their systems; and

WHEREAS, investing in our drinking water and wastewater systems will secure a bright and prosperous future for generations to come; and

WHEREAS, every individual can make a difference when it comes to conserving and saving water to protect this critical resource and promote a healthy economy and community; and

WHEREAS, the State of Tennessee recognizes that water is essential to our quality of life and economic competitiveness and acknowledges the importance of educating the public about the value of all water through the "Imagine a Day Without Water" campaign.

THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners, meeting in regular session on this the 21st day of October 2019, that this body does join with Governor Bill Lee in proclaiming **October 23, 2019** as

IMAGINE A DAY WITHOUT WATER DAY

and urging all citizens to join in this worthy observance; and

BE IT FURTHER RESOLVED that this resolution shall be spread on the minutes of this body.

Upon motion by Commissioner Moe Taylor, seconded by Commissioner Krueger, the Commission voted unanimously to approve the resolution imagining a day without water.

SUMNER COUNTY PHASE I CAPITAL PLAN

Chairman Langford recognized Mike Thomas from Justice Planning Associates, Inc., who presented the Sumner County Phase I Capital Plan, outlining the costs and timelines of design and development of the new courthouse, two jail pods and the parking garage. Mr. Thomas reported that new related projects and expenses totaled \$11,252,470.00. With an owner's contingency of \$2 million, the total cost of the Phase I Capital Plan was \$91,009,913.00. The projected opening date of the new courthouse is December, 2022.

He said two jail pods would provide a total of 128 inmate beds. The parking garage was moved to the beginning of the project in an effort to partner with the City of Gallatin on the construction cost. He said Phase II would add two more jail pods for an additional 128 beds. In addition, he said Phase II would include remodeling the old Courthouse and the General Sessions offices for additional space in the Sheriff's Office and the jail.

RECOGNITION OF THE PUBLIC

Chairman Langford opened the floor to allow the public to speak concerning any matter on the agenda.

The following spoke in favor of the courthouse construction project:

Jay Ingrum of 755B Newton Lane in Gallatin Mark Smith, Sumner County Clerk and Master, of 825 East Main Street in Gallatin Shawn Fennell and Jimmy Overton, City of Gallatin Councilmen, spoke about the city's commitment to a partnership with the County to build the parking garage. Russ Edwards of 133 Windham Circle in Hendersonville Kathryn Strong, Circuit Court Clerk Ruth Fennell spoke against borrowing money to pay for the courthouse construction project and requested more responsibility to the property taxpayers.

With no one else wishing to speak, recognition of the public was closed.

LEGISLATIVE COMMITTEE

Commissioner Ring introduced the following resolution and moved for approval; Commissioner Moe Taylor seconded the motion

1910-01 A RESOLUTION SEEKING THE REMOVAL OF EPA VEHICLE TESTING REQUIREMENTS FOR SUMNER AND SIMILARLY SITUATED COUNTIES IN TENNESSEE

WHEREAS, in May of 2018, the Tennessee General Assembly enacted legislation which would eliminate the vehicle emission testing program for vehicles in Sumner and similarly situated counties in Tennessee as soon as the EPA sanctioned such change; and

WHEREAS, for several years, prior to and since the passage of this law, Sumner County has met EPA compliance standards; and

WHEREAS, though promised that the final process would take six months to a year, it appears that no action seems to have been taken to remove this costly and time-consuming restriction placed on Sumner County citizens.

THEREFORE, be it resolved by the Sumner County Board of County Commissioners, meeting in regular session on this the 21st day of October, 2019 that this body does hereby ask our senators and representative to seek legislation to remove this regulation from EPA control and return it to the state coverage, in order that Sumner County and other counties, who have worked so hard to meet standards, are no longer forced to undertake emissions testing; and

BE IT FURTHER RESOLVED that the Office of the Law Director is to provide a copy of this resolution to our federal delegates.

Chairman Langford declared the resolution approved by the body upon unanimous voice vote.

Commissioner Ring introduced the following resolution and moved for approval; Commissioner Tinsley seconded the motion.

1910-02 A RESOLUTION ADOPTING A PILOT PROCEDURE FOR RECORDING DESIGNATED COMMITTEE MEETINGS IN AN AUDIO-VISUAL FORMAT

WHEREAS, Sumner County wishes to allow citizens to view designated committee meetings and therefore adopts pilot procedures for making audio/visual recordings ("A/V Recordings"); and

WHEREAS, due to the many committees and meetings that this body undertakes, the numerous locations that such meetings must be held and because of limited time, space, staff costs, and equipment to make such recordings, all committees may not be recorded in the A/V Recordings format; and

WHEREAS, this A/V Recordings service shall not serve as an ongoing obligation, change the manner in which the official records of the county are maintained nor replace the official written minutes of the body; and

WHEREAS, not recording a meeting does not indicate failure or mistake of county employees to perform any duty, and moreover, the possibility of equipment failure is understood in our technology driven world.

THEREFORE, this body does hereby adopt, the following pilot procedures for A/V Recordings:

(1) Equipment will be stored in and maintained by the Information Technology Office ("IT") and maintained by that office; and

(2) Minute takers, committee chairs or staff will all work together to obtain the equipment for use at a meeting.

- (3) The standing committees of this body:
 - a. Budget;
 - b. Legislative;
 - c. Highway;
 - d. Committee on Committees;
 - e. Education;
 - f. Emergency Services; and
 - g. General Operations

shall have first choice for usage of the equipment; and

(4) Planning Commission Meetings and Board of Zoning Appeals meetings will also be considered for recording with the equipment, in the locations where those committees normally meet; and

(5) Other permanent committees, as well as short term or limited topic Ad hoc committees will be last considered for recording with the equipment.

(6) Certain discussions regarding medical, criminal, pending legal matters or other legally confidential topics will not be recorded.

(7) Due to multiple meetings which may overlap, the committee scheduled to use the equipment shall be allowed to finish their meeting. The decision to start a meeting without available equipment does not imply anything covert or unethical action but is simply the decision of a chairman to allow the timely start of scheduled meetings.

(8) The action of recording the committee meeting shall NOT serve as an ongoing obligation, change the manner in which the official records of the county are maintained nor replace the official written minutes of the body. Such A/V recordings are only undertaken to offer, when available, another manner to hear and see the debate of the committees chosen for recording. (9) This body can suspend or discontinue this process at any time for any reason.

(10) Once completed, IT will place the recordings on a Youtube.com channel and/or the county website, if available.

(11) This Pilot program will be reviewed as needed and changed, amended or withdrawn depending on the findings of the commission.

Commissioner Moe Taylor moved to amend the resolution, seconded by Commissioner Mansfield, to delete references to "pilot" and substitute the word, "process".

In all other counties, a school zone is only allowed on the roadway adjacent to school grounds; and

WHEREAS, Sumner County, in support of the City of Portland and the City of White House, does hereby petition the State General Assembly to amend TCA 55-8-152(d)(2) to authorize Sumner County to be included with those counties listed in TDOT Operations Memorandum 1801, so school zones can be placed for the public good.
