MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS AUGUST 17, 2020

The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, August 17, 2020, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Scott Langford. Also present were the County Clerk Bill Kemp, County Mayor Anthony Holt and County Law Director Leah Dennen and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Sheriff Sonny Weatherford. Chairman Scott Langford noted that with twenty-three members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session. Commissioner Steve Graves was not present.

The Invocation was led by Kevin Rector, lead Pastor at Gallatin First Church of the Nazarene.

The Pledge of Allegiance was led by the County Clerk, Bill Kemp.

Chairman Langford reported that the video projector was not operating, so he asked commissioners to clarify how they voted if any questions arise during the voting process.

APPROVAL OF AGENDA

Commissioner Krueger moved, seconded by Commissioner Chris Taylor, to adopt the agenda. The Commission approved the agenda by voice vote of the body. Commissioner Moe Taylor voted no.

APPROVAL OF MINUTES

The minutes for the meeting of this body held on July 20, 2020, and recorded in the office of the Clerk, Bill Kemp, were approved by unanimous voice vote after Commissioner Foster made the motion, seconded by Commissioner Ring.

RECOGNITION OF THE PUBLIC

Chairman Langford opened the floor to allow the public to speak concerning any matter on the agenda.

Colonel Don Scruggs of 141 Bushs Lane in Gallatin spoke against the expenditure on the Comer Barn.

Van Oldham of 108 The Landings in Hendersonville spoke in favor of the Meadows development.

Ginny Hall Plunkett of 395 Devon Chase Hill in Gallatin spoke against the expenditure on the Comer Barn and the proposed annexation of the Meadows.

Bob Brown of 587 Forest Retreat Road in Hendersonville spoke against the proposed annexation of the Meadows and the funding of the Comer Barn.

Fred Duffer of 816 Lock 4 Road in Gallatin spoke against the Comer Barn funding and the approval of the proposed annexation of the Meadows.

Frosty Gregory of 201 Wallace Road in Gallatin said his property adjoined the Meadows and spoke in favor of the annexation.

Robert Ream of 463 Dobbins Pike in Gallatin lives next door to the property and stated his approval of the Meadows annexation.

Russ Rainear of 199 Rainear Lane in Gallatin spoke in favor of the Meadows annexation.

John Miller of 104 Pond Drive in Gallatin stated he was opposed to the Comer Barn funding as currently proposed. He suggested making it a festival market place and restructuring the agreement with Rogers Group, among other suggestions.

Susie Robinson of 2695 Long Hollow Pike in Hendersonville finished the previous speaker's points and spoke against the Comer Barn.

David Klein of 398 Branham Mill Road in Gallatin said exponential growth should accompany increased impact fees to pay for the infrastructure needs of the county.

Michelle Jouvence of 1335 Long Hollow Pike in Gallatin stated that if the Comer Barn is moved to her property, she would fund the upgrades. She spoke against the proposed annexation of the Meadows and further expansion.

MINUTE BOOK TWENTY-TWO AUGUST 17, 2020

Kevin Baigert of 424 AB Wade Road in Portland questioned the role of the County in the renovation of the Comer Barn. He spoke against the annexation of the Meadows because of the additional tax burden.

John Puryear of 1490 Cherokee Road spoke in favor of funding the Comer Barn.

Alison Turner of 1289 Lock 4 Road in Gallatin spoke as a civil engineer and representative of the Meadows property. She said the development is well designed and appropriate for the location.

Joe Wallace of 445 Wallace Road in Gallatin has property adjoining the Meadows and wished it could remain a pastoral farm. He warned of other uses for the property that could be much worse.

Lee-Anne Thomas of 902 Wallace Road in Gallatin spoke against the Meadows annexation.

Kyle Robinson of 414 Upper Station Camp Creek Road in Gallatin stated his concern for the lack of planning and transparency, regarding the Meadows and the Comer Barn.

Ruth Fennell 1049 Blue Jay Way in Gallatin spoke against the funding of the Comer Barn and the approval of the proposed Meadows annexation.

Dave Dozier of 567 Dobbins Pike in Gallatin stated his opposition to the Meadows annexation and uncontrolled growth.

Tonya Dozier of 567 Dobbins Pike in Gallatin spoke against the Meadows annexation.

Jimmy Johnston of 1598 Greenlea Boulevard in Gallatin and representative of Forward Sumner spoke in favor of the Comer Barn and the Meadows annexation.

Wanda McVey of 221 Beacon Street in Gallatin asked the Commission to vote against the Comer Barn funding. She spoke against the Meadows annexation.

Margaret Whiticker of 539 Dobbins Pike in Gallatin stated her property adjoins the proposed annexation. She is against the annexation because Dobbins Pike has dangerous traffic without adding to the population density.

Alice Reardon of 166 Phosphate Lane in Gallatin stated her opposition to the Meadows annexation, saying that the project was not well planned.

Jimmy Overton, a City of Gallatin Councilman, spoke in favor of the Meadows annexation.

With no one else wishing to speak, recognition of the public was closed.

RECESS

Chairman Langford declared a recess at 8:50 p.m. Chairman Langford declared the Commission reconvened at 9:03 p.m.

2008-08 A RESOLUTION AUTHORIZING A PLAN FOR COMER BARN PRESERVATION AND APPROPRIATING \$503,295 CONSISTING OF \$250,000 IN MATCHING FUNDS TO BE PAID FROM THE HOSPITAL SALE PROCEEDS DESIGNATION, ACCEPTING AND APPROPRIATING THE \$250,000 STATE OF TENNESSEE ENDOWMENT, ACCEPTING AND APPROPRIATING \$3,295 IN PRIVATE DONATIONS AND OTHER COSTS TO BE PAID BY DONATIONS AND TOURISM FUNDS COLLECTED TO PRESERVE THE FACILITY

WHEREAS, the old stone barn known as the Comer Barn is a county treasure which should be preserved for future generations and safeguarding it from the elements as well as human and animal intervention is the goal of this body; and

WHEREAS, Rogers Group is supportive of our preservation plans to renovate the barn and has provided a signed Memorandum of Understanding for a Reformation Deed that will include permanent easement access as well as a repurchase clause in the event Sumner County fails to complete renovations; and

WHEREAS, Rogers Group is already in the process of building a berm and tree line to improve the visual backdrop of the barn property; and

WHEREAS, upon architectural plan submission, Rogers Group has offered to provide all necessary stone and paving to build an entry lane and parking lot on the surrounding property; and

WHEREAS, a \$250,000 grant has been provided by the State of Tennessee to assist in the cost of preserving the facility, and this body wishes to appropriate additional matching funds in the amount of \$250,000 from the

hospital sale proceeds designation and private donations have been received in the amount of \$3,295, for a total of \$503,295; and

WHEREAS, civic fundraising is being organized and grants are being pursued to minimize use of any additional funding from county tourism hotel/motel tax income to preserve this unique landmark; and

WHEREAS, funds allocated will be used in the following order of priority until the \$503.295 total allocation is exhausted:

- Secure a survey to properly define the barn property in the Reformation Deed
- 2. Install security cameras/signage and secure entrances
- 3. Stabilize the structure as necessary
- 4. Install a new, insulated metal roof
- 5. Remove rotted wood/materials in interior areas and begin renovations on historic elements including windows, doors, walkways, etc.

THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on this the 17th day of August 2020, that this body does hereby appropriate \$503,295 to the Comer Barn preservation project consisting of \$250,000 as matching monies from the hospital sale proceeds designation and \$250,000 from the State of Tennessee to the Comer Barn preservation project and \$3,295 from private donations; and

BE IT FURTHER RESOLVED that any additional cost over the \$503,295 shall be funded with private donations, grants, and tourism hotel/motel tax revenues; and

BE IT FURTHER RESOLVED that we accept the state endowment offered by the State of Tennessee; and

BE IT FURTHER RESOLVED that pursuant to financial state and local bidding guidelines, a project manager, architect, engineer, or other professional shall be engaged to oversee the preservation of the Comer Barn including roof repairs and related items necessary for conservation and safeguarding of the barn; and

BE IT FURTHER RESOLVED that upon completion and acceptance of this resolution, Sumner County will secure a survey to properly define the barn property in the Reformation Deed; and

BE IT FURTHER RESOLVED that no county funds will be spent until the Reformation Deed is legally amended.

Chairman Langford recognized Commissioner DeWitt who gave a presentation on the possibilities for use of the Comer Barn and the ongoing revision of the agreement with Rogers Group. She requested the approval of a private donation received in the amount of \$3,295.00. Without objection, the matter was added to the prepared resolution.

Commissioner Mansfield moved, seconded by Commissioner Moe Taylor, to give the \$250,000.00 back to the State of Tennessee and the Comer Barn back to Rogers Group. Chairman Langford ruled that the amendment was contradictory to the main motion.

Commissioner Moe Taylor called for a point of clarification as to why Commissioner Chris Taylor could speak without getting in the queue. Chairman

Langford stated that it was the prerogative of the Budget Chairman to speak to his motion.

Commissioner Becker moved, seconded by Commissioner DeWitt, to return the Comer Barn to Rogers Group if the resolution does not pass.
