The scheduled meeting of the Historic Commission was brought to order with an invocation by Alderman Hayes on November 10, 2020 at 3:10 p.m. in the Sumner County Administration Building.

#### 3. Agenda.

# 4. Approval of the Minutes - September 1, 2020.

Chairman DeWitt requested wording be changed under conception presentations. Upon motion of Alderman Hayes, seconded by Comm. Hinton, the Committee voted unanimously to approve the minutes of September 1, 2020, as amended.

#### 5. Report of the Chairman.

Chairman DeWitt stated that White House Utility District is preforming infrastructure upgrades in the right of way along Nashville Pike in front of Comer Barn. Chairman DeWitt also updated the Committee on the completion of the Reformation Deed. A draft has been sent to Rogers Group for review and the legal description will be added as soon as the survey is completed by Richard Graves. The Reformation Deed must be completed before any money is spent.

Chairman DeWitt informed the Committee that she is in the process of setting up a non-profit called Preservation Foundation of Sumner County which has been incorporated and will raise funds in addition to the current budget. Once the inaugural board is in place a sponsorship plan for recognition will be provided to the community. There are upcoming fundraiser events such as recognizing contributions of \$500.00 or \$1,000.00 with a Bill Puryear print and a chocolate themed event at the Palace Theater in Gallatin on February 12, 2021.

Chairman DeWitt encouraged the members to take the ideas log, that was presented at the September 1, 2020 meeting, and engage with the community to receive feedback and ideas.

Chairman DeWitt opened discussion about the bid process for the repair/replacement of the roof. There was a mandatory onsite visit on October 28, 2020 and was attended by 6 potential contractors, however only one bid was submitted by the 10:00 am November 5, 2020 deadline. Chairman DeWitt did receive the following feedback from the contractors who were present at the onsite visit but did not bid:

- Best Choice Roofing did not submit due to lack of sufficient construction skills for this specific project
- WCC ran out of time to finalize price (per Bryant/Planning Department during bid opening on November 5, 2020)
- Baker Roofing person assigned to provide bid had medical emergency and no one was able to complete bid in his absence; they were apologetic and disappointed they were unable to provide a bid
- Above All Roofing and Exteriors not bonded, therefore not qualified to submit on this project
- Two Rivers Roofing would have loved to submit and believe themselves well qualified for the project; their ability to provide services in this near term became a scheduling conflict with another large project related to the March 3<sup>rd</sup> tornado
- Brian Harris Homes submitted

The bid for asphalt shingles came in at \$453,986.00 while the amount for metal roofing is \$510,789.00, there is a possible duplicate line item which could result in a \$10,944.00 deduction. Richard Jones, Sumner County engineer and Matt Harris, Brian Harris Homes are to discuss any duplicate line items that need to be adjusted and potential value engineering charges. Brian Harris Homes is also willing to deduct on the final bill for reduction in lumber prices. Simpson Strong Tie has offered to donate the fasteners, connectors and anchor plates for the project.

There were a few concerns discussed such as receiving a single bid and the amount being essentially equal to the approved budget. Some would like confirmation that the contractor is able to complete a project of this magnitude due to being primarily a residential home builder. Also addressed was the importance to honor and fairly handle the time and effort put forth by Brian Harris Homes to submit their bid. Chairman DeWitt also stated that while the Committee may have input, they do not have authority to accept or reject the bid.

# 11. Zoning.

a. Lewis Head Commercial Plaza – Lewis Head, Developer represented by Green LID Design. Applicant is seeking a rezoning from Rural Residential (RR) to Planned Unit Development (PUD) for the purpose of constructing and operating a commercial development containing Automotive Repair and Services, Financial, Consultative and Administrative Services, General Business and Communication Services, General Personal Services and General Retail Trade. Subject property is located at 131 and 135 W. Roberts Road, Portland, TN. 37048, is on tax map 72, parcel 035.06 and 035.07, contains 10.10 acres and is zoned Rural Residential (RR). (Second Reading)

Chairman Ring recognized Comm. Foster who spoke about the concerns some residents have about the quality of their drinking water, the potential for the water to be affected and the increased traffic this may bring to the road. Comm. Foster expressed the frustration of residents who are opposed to the rezoning request and feel that their concerns have not been addressed. Comm. Foster asked the Committee to defer the vote on this request until a meeting with these residents has occurred. Leah Dennen, County Law Director explained that this is the second reading and has been noticed therefore will have to move on to the Commission for vote, if passed by the Committee. Comm. Foster informed the Committee he will vote against this request until a meeting with the residents is agreed upon.

Chairman Ring recognized Comm. Goode who asked if Planning Director Josh Suddath could work with Andy Leath, Green LID Design, to arrange a public meeting to address the concerns. Mr. Suddath is willing to work with Mr. Leath and stated a neighborhood meeting was held electronically. Mr. Leath said he is not opposed to another public meeting and would talk to his clients but also stated certified letters were mailed out inviting residents to speak at the planning commission meetings as well as the county commission meeting in November. He feels like the concerns have been addressed the best they can with the tools available. Traffic studies have been completed and county stormwater has addressed the issues of ground and surface water.

Upon motion of Comm. Goode, seconded by Comm. Langford, the Committee voted unanimously to approve the rezoning of Lewis Head Commercial Plaza on the second reading.

The joint work session between the Sumner County Parks and Recreation Committee and the Planning Commission was brought to order by Anthony Holt, County Mayor on October 27, 2020 at 4:03 p.m. in the Sumner County Administration Building in Gallatin.

Mr. Holt opened the meeting with an overview of the purchase of property for the Liberty Creek School site. The county purchased 265 acres off of Upper Station Camp Creek Road in 2015 for \$3,500,000.00 for a school complex and park. In 2017, William Brown generously gifted \$8,000,000.00 with \$7,500,000.00 to be used for technology in the schools and \$500,000.00 to be used for a park on the property.

Mr. Holt explained the compressed timeline for the approval of the Sumner County Parks Master Plan. He explained the application deadline for a \$500,000.00 matching funds TDEC grant is December 7, 2020 with the matching funds to come from the \$500,000.00 set aside by the Brown Trust for the creation of the park. The importance of the application being submitted during the first acceptance cycle for the grant was discussed.

Kim Norfleet, Grants Administrator gave a timeline for upcoming meetings that are required in order to fulfill the requirements of TDEC for the grant application. The first of two public meetings will be held October 29, 2020 at 5:30 pm at Bledsoe Fort Historical Park and a virtual meeting will take place on November 5, 2020 at 5:30 pm. The Parks and Recreation Board will meet in November to vote on the Master Plan and park plan for the William and Martha Brown Memorial Park at Liberty Creek, if approved then it will be forwarded to Planning Commission for vote at their November 24, 2020 meeting.

Josh Bethea of CSDG presented a draft of the Sumner County Parks Master Plan. Some of the ideas discussed where:

- Purpose and Goals
- Growth and Connectivity

- Mission, Vision and Core Values
- County History
- Planning Process
- Guiding Principles
- Staff and Funding
- Key Findings
- Action Plan
- Future Opportunities and Funding Needs

Josh Bethea gave a presentation on the William and Martha Brown Memorial Park at Liberty Creek. He displayed a location map which showed the school locations. Property constraints and natural features. The component part of the plan included the Brown house location and noted that it is not part of the grant. The following were also discussed:

- Natural walkways and native grasslands
- Existing farm roads
- Pavilion location
- 40x60 structure with restrooms
- Overlook points

Also noted one creek crossing and a natural amphitheater utilizing some of the natural features already on site.

He stated the following roads need access to water: Henry Harris Road, Bishop Troutt Road, Rabe Coates Road, Hershel Lyles Road, Bill Henson Road, Ada Coates Road, George Akins Road, Lake Road, Tom Beasley Road, West John Davis Road, East John Davis Road, Pleasant Grove Road, Coleytown Road, Dewey Carr Road, and Austin Peay Highway.
- F. Discussion- There was discussion amongst committee members and Mayor Jerry Kirkman. Commissioner Chris Taylor mentioned that if a grant is approved, we will look at approving match money in fiscal year 2022. Chairman Taylor stated in December's meeting, the committee will work on narrowing down the list of roads that need access. The committee agreed to meet December 7, 2020 at 4:45 pm.
