The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, December 14, 2020, at 7:00 p.m., electronically using a Zoom computer format. The Invocation was led by Chairman Langford.

After roll call, Chairman Langford declared a duly constituted quorum, and the meeting was opened in due process. Chairman Scott Langford noted that with twenty three members participating electronically, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session. Commissioner Luke Tinsley was the only member not present.

The Pledge of Allegiance was led by the County Clerk, Bill Kemp.

APPROVAL OF AGENDA

Commissioner DeWitt moved, and was duly seconded by Commissioner Graves, to adopt the agenda. The Commission approved the agenda by unanimous voice vote of the body.

APPROVAL OF MINUTES

The minutes for the meeting of this body held on November 30, 2020 and recorded in the office of the Clerk, Bill Kemp, were approved unanimously by voice vote after Commissioner Ring made the motion, seconded by Commissioner Tucker.

RECOGNITION OF THE PUBLIC

With no emailed comments received, recognition of the public was closed.

REPORT OF THE CHAIR

Chairman Langford noted that the Veterans Service Officer's report was provided for information only.

Chairman Langford informed the Commission that the Governor's order is expected to expire on December 31, 2020. He will continue to monitor local COVID-19 numbers and any actions taken by the Governor and update everyone as soon as possible on how the upcoming meetings will be conducted.

Chairman Langford noted that he will introduce an IT Support Ad Hoc Committee to the Legislative Committee in January after discussion with another commissioner to make sure the IT department has the support needed to serve the County while integrating multiple departments.

Chairman Langford recognized Commissioner Moe Taylor who asked if a Redistricting Committee would be formed. Chairman Langford stated he would provide an update after he speaks with the Administrator of Elections Lori Atchley, County Mayor Anthony Holt and Law Director Leah Dennen.
