He stated if he projected revenues for the general fund today, we are running approximately \$1,000,000 better than projected, but we budgeted an additional \$2,000,000 of fund balance than usual. Finance Director Lawing stated a 1% COLA raise for employees will be approximately \$430K, and we have picked up a significant amount of revenue, but things are not stable. He recommended to defer any action until January or February.
