He explained gas tax is below prior fiscal year for the first six months at approximately \$76K. Finance Director Lawing stated the county general fund is approximately \$1.2M more than anticipated, but we budgeted \$2.3M more of fund balance. He went on to explain that the debt service fund looks significantly better than budget, and we will not need to dip into debt service reserves.

Report of the Fire Department.

Joe McLaughlin of the Cottontown Volunteer Fire Department reported there were 4,799 calls reported in 2020, with an increase of approximately 42 calls over the previous year. There were 351 calls received in January with Shackle Island not reporting.

10. Report of the Emergency Services Director.

Greg Miller, Emergency Medical Services Chief, reported there was an increase in responses and transports in 2020 over previous years. He noted that revenue is down approximately \$100,000.00 for the month of January due to a billing company change, because of the contract transfer there is a 90 day billing delay. There has also been a delay in receiving payments from Tenncare but both should catch up around March 2021.

Comm. Kreuger questioned if the delay in receiving the payments will impact the budget. Mr. Miller responded that the revenue slow down should correct itself before budget talks begin.

11. Report of the Emergency Management Agency.

Ken Weidner, Director of the Emergency Management Agency reported that they have been working with the health department distributing COVID-19 vaccines. He updated on the progress of the installation of the new communications tower in the Beech School area. He also stated that they are continuing to move agencies over to the new communications system.

12. Report of the Emergency Communications Center.

Director Marilyn Anderson reported 3 positive Covid-19 cases in January and provided a staffing update noting 10 vacancies including two resignations in February with the possibility of 6 new hires. Ms. Anderson stated call numbers are increasing with 25,356 for the month of January and a total of 335,699 for the year of 2020. She also discussed the AT&T service disruption due to the bombing in Nashville on Christmas Day.
