- I. CALL TO ORDER by Chairman Taylor at 8:30 am in Room 112 of the Sumner County Administration Building in Gallatin,
  - A. Invocation- Led by Commissioner Geminden.
  - B. Approval of Agenda- Motion to approve by Commissioner DeWitt, second by Commissioner Schell, unanimous approval.
  - C. Recognition of Public-None
- II. REPORT OF THE BUDGET COMMITTEE CHAIRMAN- Chairman Taylor stated we have not been given any direction on how we can spend the CARES money. He stated he would like to approach it as if we can use it for infrastructure. Chairman Taylor explained that Road Superintendent Hardin will hopefully have a four-year plan with her today on how to replace all roads in Sumner County, with preventative measures and estimated costs. Chairman Taylor stated at this time, the cost is approximately \$13M. Chairman Taylor pointed out that the committee's goal is to give a 4% raise to all employees but may be reduced to balance the budget. Chairman Taylor explained that there has been changes to E-911, and the county IT department will be taking over most of their IT functions.

Commissioner Geminden stated he wishes there was a way for all homes in the county to post their address to help EMS, fire, and other departments.

Chairman Taylor informed the committee that he met with all the fire chiefs, which do a great job with their operating expenses but will never get ahead on their large equipment. He stated the fire chiefs are going to put together a list of the large equipment needed for each station, prioritize it, and present it to the committee. Chairman Taylor stated we may be able to help them get ahead with some of the CARES money or funds from capital projects. He explained the volunteer fire departments are happy with the appropriation they are currently receiving if we could help them replace their large equipment.

#### III. REPORT OF THE FINANCE DIRECTOR

- A. Overall Budget- Finance Director Lawing gave an overall budget presentation on the screen to the committee members. He explained last year's difference between revenues and expenditures is approximately \$6M, due to COVID. Looking at next year, we are up approximately \$7.1M, with \$5M being a request for waterlines out of the hospital funds. The remainder is cost of living adjustments, additional employees, and salary requests, amongst a few other things. Finance Director Lawing stated even if the waterlines are removed, we are still approximately \$2.1M worse than last year. He recommended shrinking that gap as much as possible. Finance Director Lawing stated the courthouse and jail maintenance fund is balanced but is slowly deteriorating for a couple of reasons: one is because litigation taxes are down due to the courts being closed and the other is the commission for inmate telephone calls is down. He stated the drug control fund is proposed by the sheriff and probably doesn't need to be reviewed. The debt service fund has picked up fund balance, but we use those balances for debt until it drops off. He stated the highway public works fund barely breaks even. He went on to explain the budget worksheet main tab to the committee.
- B. Benchmarking- Finance Director Lawing provided a benchmarking worksheet to the committee (attached) and briefly explained. He pointed out that this was based on financials only.

He informed the committee that the call volume has increased dramatically over the last few months resulting in them giving away calls every day. Chief Miller requested an additional \$100K of part time funds to run another ambulance five days a week, 12 hours a day, during their busy times. Chief Miller stated he is averaging giving away three calls a day at a conservative \$300 per call. Chief Miller estimated \$320K additional revenue. Finance Director Lawing added \$250K additional revenues for patient charges for fiscal year 2022 and added 4% additional revenue to the current year budget. Chief Miller stated he felt comfortable with that. Finance Director Lawing stated he is estimating approximately \$8,809,000 for patient charges for fiscal year 2022, and Chief Miller agreed.

He stated, once the courts fully open, due to the amount of people awaiting trial, there will be more than enough inmates to cover the projected revenue. Finance Director Lawing requested the projected state board bill revenue to be \$2.8M. Deputy Chief Pickard presented and informed the committee they are 52 correction officers short. He requested to dissolve five vacant corrections positions and use that money to spread across all non-supervisory jail positions. Finance Director Lawing requested to take all vacant positions to single on health insurance and use the estimated \$250K for the vacant correctional positions for raises, as requested above by Chief Deputy Pickard. Finance Director Lawing pointed out that this was not the case. He explained that Ms. Haw and Ms. Atchley were both present for the meeting where this was discussed. He stated the numbers used by the committee were based on prior presidential elections. For example, Ms. Haw stated they requested \$200K, pre COVID, and only spent \$137K, which was inclusive of COVID increases. Finance Director Lawing stated it appears their budget was significantly over requested or contained potential errors. Ms. Haw agreed that their requests were large. Motion to defer until June by Chairman Taylor, second by Commissioner Schell, unanimous approval.

- II. REPORT OF THE BUDGET COMMITTEE CHAIRMAN-Chairman Taylor pointed out that the CARES money will have restrictions on how it can be spent. Chairman Taylor stated he has asked Finance Director Lawing to pull out any items from EMS, EMA, and the sheriff's office that is COVID related and can be paid for with the CARES money. Chairman Taylor mentioned that the rural fire departments are creating a list of all the large equipment they need, prioritizing it, and will submit it back to the committee by month end. Chairman Taylor requested, if the committee is comfortable, we can fund the building and codes director's and the planning director's raises in full and all additional raises above COLA will be reduced by 50%. He also pointed out that we can reduce the sheriff's office by one employee, look at a 3% COLA versus 4%, and remove some of the additional requests from the election commission. In doing this, we will be at an approximate \$260K deficit, which is inclusive of a \$100K increase in revenues for state board bills.
- III. REPORT OF THE FINANCE DIRECTOR- Finance Director Lawing informed the committee that the bond was issued yesterday. He pointed out that we received the lowest true interest cost in history, 1.49% on 20-year bonds inclusive of refinancing. Finance Director Lawing stated the county will save approximately \$1.6M over a two-year period.

Todd Draper presented the judicial magistrates' budget.

Finance Director Lawing presented the finance department's budget. He provided the committee with a salary survey from Rutherford County Government (attached). The committee agreed to fund a new position in the finance department and to treat his additional raises as all the other departments.
