WHEREAS, Section 5-9-109, of the <u>Tennessee Code Annotated</u>, authorizes the county legislative body to make appropriations to non-profit charitable organizations; and

WHEREAS the Sumner County Legislative Body recognizes that the various non-profit charitable organizations located in Sumner County need funds to carry on their non-profit charitable work; and

WHEREAS it is the expressed interest of the County Commission of Sumner County in providing these funds to non-profit charitable organizations to be fully in compliance with the Rules of the Comptroller of the Treasury, with Section 5-9-109 of the <u>Tennessee Code Annotated</u>, and with any and all other laws and prior resolutions of this body which may apply to county appropriations to non-profit organizations;

THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on the 21st day of June 2021 that the following be appropriated.

- 1) The non-profit charitable organizations to which funds are appropriated shall file, with the county clerk and the disbursing official, a copy of an annual report of its business affairs and transactions and the proposed use of the county's funds in accordance with rules promulgated by the Comptroller of the Treasury. Such annual report shall be prepared and certified by the chief financial officer of such non-profit organization in accordance with Section 5-9-109(c) of the <u>Tennessee Code Annotated</u>.
- 2) Said funds must only be used by the named non-profit charitable organization in furtherance of their non-profit charitable purposes benefiting the general welfare of the residents of the county.
- All amounts paid to the tourism board are limited to the lesser of the budgeted amount or the hotel/motel tax collections less the applicable trustee's commission.

This resolution shall become effective upon passage, the public welfare requiring it.

BE IT FURTHER RESOLVED, pursuant to the 2002 Financial Management Act, the 2012 Financial Management Act, and the 1981 Local Optional Law, that if the need shall arise, the budget committee, with the approval of any official, head of any department or division which may be affected, may transfer any amount within any major appropriation category. Also, the approval of the county board of commissioners must be obtained, as required by law, for transfers between major appropriation categories within the same fund.

Aforesaid authorization shall clearly state the reason for the transfer(s), but this provision shall in no case whatsoever be construed as authorizing transfers from one fund to another but shall apply solely to transfers within a certain fund.

BE IT FURTHER RESOLVED that any appropriations made by this resolution, which cover the same purpose for which a specific appropriation is made by statute, are made in lieu of but not in addition to said statutory appropriation. The salary, wages, or remuneration of each officer, employee, or agent of the county shall not be in excess of the amounts authorized by existing law or as set forth in the estimate of expenditures which accompanies this resolution. Provided, however, that appropriations for such salaries, wages or other remuneration hereby authorized shall in no case be construed as permitting expenditures for an office, agency, institution, division or department of the county in excess of the appropriation made herein for such office, agency, institution, division or department of the county. Such appropriation shall constitute the limit to the expenditures of any office, agency, institution, division or department for the fiscal year ending June 30, 2022. The aggregate expenditures for any item of appropriation shall in no instance be more than the amount herein appropriated for such item.

BE IT FURTHER RESOLVED that the detailed "Sumner County Government Consolidated Annual Budget for the Fiscal Year Ended June 30, 2022" is adopted by reference for line-item detail.

BE IT FURTHER RESOLVED that any resolution which may hereafter be presented to the board of county commissioners providing for appropriations in addition to those made by this budget appropriation resolution shall specifically provide sufficient revenue or other funds, actually to be provided during the fiscal year in which the expenditure is to be made, to meet such additional appropriations.

BE IT FURTHER RESOLVED that there is hereby appropriated for state approved projects such amount or amounts as may from time-to-time be approved by contract with the State of Tennessee Department of Transportation.

BE IT FURTHER REOLVED that the county mayor and the county clerk are hereby authorized to borrow money on revenue anticipation notes, provided such notes are first approved by the director of local finance, to pay for the expenses herein authorized until the taxes and other revenue for the fiscal year 2021-2022 have been collected. The proceeds of loans for each individual fund shall not exceed 60% of the appropriations of each individual fund and shall only be used to pay the expenses and other requirements of the fund for which the loan is made. The loan shall be paid out of revenue from the fund for which money is borrowed. The notes evidencing the loans authorized under this section shall be issued under the applicable sections of Title 9, Chapter 21, Tennessee Code Annotated. Said notes shall be signed by the county mayor and countersigned by the county clerk and shall mature and be paid in full without renewal no later than June 30, 2022.

BE IT FURTHER RESOLVED that the delinquent county property taxes for the year 2020 and prior years and the interest and penalty thereon collected during the year ending June 30, 2022 shall be apportioned to the various county funds according to the subdivision of the tax levy for the year 2020. The clerk and master and the trustee are hereby authorized and directed to make such apportionment accordingly.

BE IT FURTHER RESOLVED that all unencumbered balances of appropriations remaining at the end of the fiscal year shall lapse and be of no further effect at the end of the fiscal year at June 30, 2022.

BE IT FURTHER RESOLVED that any resolution or part of a resolution which has been passed by the board of county commissioners that is in conflict with any provision in this resolution is hereby repealed.

BE IT FURTHER RESOLVED that this resolution shall take effect from and after its passage and its provisions shall be in force from and after July 1, 2021. This resolution shall be spread upon the minutes of the board of county commissioners.

She further stated that as an employee it is not a direct conflict of interest when voting on the entire budget.

LEGISLATIVE COMMITTEE

Commissioner Ring introduced the following resolution and moved for approval; Commissioner Goode seconded the motion.

2106-05 A RESOLUTION MODIFYING THE COMPOSITION OF THE MEMBERSHIP OF THE LIABILITY CLAIMS COMMITTEE ("LCC") AND THEREBY THE MEMBERSHIP OF THE SELF INSURANCE BOARD ("SIB")

WHEREAS, by Resolution 0505-01, the Sumner County Board of County Commissioners created the Self Insurance Board ("SIB") to oversee the functions and operations of the Employee Benefits Committee ("EBC") and the Liability Claims Committee ("LCC"); and

WHEREAS, in May 2018, the Sumner County Board of Education withdrew from the plan of employee health, dental, and life insurance benefits administered by the **EBC** and created their own plan for employees benefits for their employees and families; and

WHEREAS, the Sumner County Board of Education, effective July 1, 2021 will withdraw from the plan of liability coverage as well as all other exposure plan and therefore withdraw from the Liability Claims Committee; and

WHEREAS, the purpose of this Resolution is to modify the operation and composition of the members of those committees (SIB & LCC) given the change in the members covered by the plans.

THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session this 21St day of June 2021, that this body does hereby adopt the following modifications and changes to the makeup of the **SIB**, and **LCC**; and

BE IT FURTHER RESOLVED that these amendments are necessary due to changes made in the participation by the Sumner County Board of Education in the Liability Claims Committee ("**LCC**") and thereby, the **SIB**; and

BE IT FURTHER RESOLVED that this body does hereby resolve that the composition and operation of the **EBC** and the **LCC** are modified as follows:

1. Effective July 1, 2021, the **SIB** shall be composed of the members of the **LCC** and the **EBC** in the form as amended by this resolution. All members of the **SIB** shall serve until expiration of their elected term or otherwise replaced by the body that appointed them; and

- 2. No **LCC** member shall serve past his or her elected or appointed term, but the members presently serving shall remain for the remainder of this commission term unless they choose to resign or leave their membership; and
- 3. The **LCC** shall consist of three members; there shall no longer be a Sumner County Board of Education member on the **LCC**; and
- 4. The three members of the **LCC** shall consist of the County Mayor and two members of the Sumner County Board of County Commissioners. The members of the County Commission through its committee system shall choose the two Commissioner positions of the **LCC**. All members of the **LCC** shall be voting members.

BE IT FURTHER RESOLVED that these amendments are effective immediately upon passage, the public welfare requiring it.

Chairman Langford declared Resolution 2106-05 approved by unanimous voice vote of the body.

BUDGET COMMITTEE

Commissioner Chris Taylor introduced the following resolution and moved for approval; Commissioner Foster seconded the motion.

2106-06 A RESOLUTION FIXING THE TAX LEVY IN SUMNER COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022

BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on this the 21st day of June 2021, that the property tax rate for Sumner County, Tennessee for the fiscal year beginning July 1, 2021 and ending June 30, 2022 shall be \$2.2620 on each \$100 of taxable property, which is to provide revenue for each of the following funds and otherwise conform to the following levies; and

BE IT FURTHER RESOLVED that the County Trustee shall reflect the property tax rate upon receipts used in collecting property taxes; and

BE IT FURTHER RESOLVED that all resolutions of the County Board of Commissioners of Sumner County, Tennessee which are in conflict with this resolution are hereby repealed; and

BE IT FURTHER RESOLVED that this resolution shall take effect from and after its passage, and its provisions shall be in force from and after July 1, 2021, the public welfare requiring it.

Chairman Langford recognized Commissioner Mansfield who moved to reduce the tax rate by \$0.13, seconded by Commissioner Moe Taylor.

Commissioner Chris Taylor called for a point of clarification to request any future amendments to reduce the tax rate include specific cuts to the budget.

County Mayor Anthony Holt stated he felt the motion was out of order without giving specific cuts because maintenance of effort for schools, sheriff's office, highway department and libraries. Ms. Dennen clarified that in order for the motion to be allowed, someone who voted in the affirmative for the budget would have to make a motion to reconsider that vote. Chairman Langford ruled the motion out of order.

Commissioners Mansfield and Moe Taylor objected to Chairman Langford's ruling. Chairman Langford noted that they had the opportunity to vote to set the tax rate before the budget but the amendment failed.
