2107-03 A RESOLUTION TO ALLOW PREPAYMENTS OF REAL AND PERSONAL PROPERTY TAXES IN THE OFFICE OF THE SUMNER COUNTY TRUSTEE

WHEREAS, T.C.A. 67-5-1808, authorizes the Sumner County Trustee, with the approval of the Sumner County Board of Commissioners, to accept prepayments of real and personal property for the current tax year up until the date the tax roll is received; and

WHEREAS, Sumner County is one of the fastest growing communities in Tennessee, and the Sumner County Trustee and the Sumner County Commission want to meet the needs of the citizens: and

WHEREAS, it is in the best interest of the citizens of Sumner County that such a prepayment system be authorized.

THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on this the 19th day of July 2021, that this body does hereby adopt the following policies and procedures to be carried out by the Sumner County Trustee:

SECTION 1. The Sumner County Trustee is authorized to accept prepayments of real and personal property taxes for the current tax year up until the date the tax roll is received; and

SECTION 2. Any prepayment of property taxes for the current tax year which are received before the later of July 1 or the date the property tax roll for the current year is received, shall be held in a designated revenue account established to hold undistributed taxes and then transferred to the revenue account established for the current year's taxes after the later of July 1 or the date the property tax roll for the current year is received by the Sumner County Trustee's Office; and

SECTION 3. Prior to the Trustee accepting prepayment of property taxes in accordance with T.C.A. 67-5-1808, the Trustee shall fine a plan with the Comptroller of the Treasury at least thirty (30) days prior to the acceptance of the payments.

BE IT FURTHER RESOLVED that once funds are paid, no refund can be provided.

Chairman Langford declared resolution 2107-03 approved unanimously by voice vote of the body.
