Sumner Enterprise Park—attachments will be passed out and discussed at meeting for ad hoc committee formation-Chairman Pomeroy formed an ad-hoc committee and read the members off as Bill Taylor, Chris Taylor, Paul Goode, Jerry Foster, Caroline Krueger, JP Powell, Earl Fischer, Moe Taylor, Billy Geminden, Larry Hinton, Steve Graves, Benjamin Harris, Kevin Pomeroy, Jim Vaughn, and Paul Decker. Commissioner Moe Taylor suggested more members, but Mr. Pomeroy explained that due to time constraints and the large size of the committee already, he did not intend to add any additional members.
- E. First Baptist Church parking area paving at South Water and East Bledsoe- Two projects were discussed: the church owned parking lot and an additional piece of property owned by the county that could be converted into a parking lot. A motion was made by Mr. Chris Taylor and seconded by Mr. Paul Goode to obtain bids for both projects for a cost comparison. The motion stated the cost comparison should include all costs for converting the county owned property to a parking lot (i.e. cost of a storage building and demolition of two existing houses). It also included an appropriation for \$30K for any required architectural fees. Motion failed 2-4, with Mr. Chris Taylor and Mr. Goode voting in the affirmative.
- F. Other repair projects (K. Ark) The committee determined no action necessary and informed Mr. Holt to proceed with projects.

He pointed out the way the financials are presented externally in the "Annual Financial Report, Sumner County, Tennessee". The actual expenditures for the fiscal year less prior year encumbrances (generally, prior year purchase orders) plus current year encumbrances (generally, current year purchase orders) are compared to the final budget (amended budget) for budget variances. The old system posted prior year encumbrances to a reserve account, and audit corrected it on the audited "Annual Financial Report, Sumner County, Tennessee". The Munis system posts prior year encumbrances to actual expenditures, as it should be. However, it does not have a prior year encumbrance column for internal or external reporting to remove these for budgetary comparison. Instead, it amends the budget, as shown on the attached, for prior year encumbrances (Mr. Lawing referenced pages 3-4 on the agenda). Mr. Lawing explained, at this time, he has a request to Munis for a custom report that backs out prior year encumbrances for a comparison similar to "G-3" attached. If this report is created by Munis, the finance office will reverse the budget adjustments (amendments) that are presented. However, if Munis cannot supply or create the reports needed, these amendments will need to be approved by the budget committee and county commission.
