MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS JULY 18, 2022

The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, July 18, 2022, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Scott Langford. Also present were the County Clerk Bill Kemp, County Mayor Anthony Holt and County Law Director Leah Dennen, and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Sheriff Sonny Weatherford. Chairman Scott Langford noted that with twenty members seated, a simple majority would be by twelve votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session. Commissioners Nipper, Sullivan and Chris Taylor were not present.

Chairman Langford offered a special prayer for Judge Carter's family and friends.

The Pledge of Allegiance was led by the County Clerk, Bill Kemp.

APPROVAL OF AGENDA

Chairman Langford recognized Commissioner Mansfield who asked to remove Resolutions 2207-07, 2207-12, 2207-13 and 2207-14 from the consent agenda. Chairman Langford moved Resolution 2207-07 to the Legislative report and Resolutions 2207-12, 2207-13 and 2207-14 to the Budget report.

Commissioner Foster moved, seconded by Commissioner DeWitt, to adopt the agenda as amended. The Commission approved the agenda (20-0-0) by voice vote of the body.

Chairman Langford explained there was a request to remove Resolution 2207-01 from the agenda from the attorney representing the applicant. Hearing no motion to remove from the agenda, Chairman Langford declared the hearing will be heard.

RECOGNITION OF THE PUBLIC

Chairman Langford ruled to refrain from negative comments. Jackie Leath – 143 Alexander Lane, Bethpage spoke in favor of rezoning and explained permit was denied and cannot get a court date. Venue intended to be part of retirement plan.

Tangi Leath – 143 Alexander Lane, Bethpage spoke in favor of rezoning and said the barn was built for daughter's wedding and storage, not an event center.

Jill Apple – Alexander Lane, Bethpage – not present – Tangi Leath submitted Ms. Apple's written statement in her absence.

Steve Harris – 197 Alexander Lane, Bethpage spoke in opposition of the rezone request. He stated it is not consistent with comprehensive plan for the area and infrastructure is not in place for business.

2207-08 A RESOLUTION AMENDING THE GENERAL PERSONNEL POLICY

BE IT RESOLVED, by the Sumner County Board of County Commissioners meeting in regular session on this the 18th day of July 2022, that this body hereby amends the general personnel policy as follows:

VACATION LEAVE

As of June 30 of each year, vacation time earned and balances available will be reported to the finance department for each full-time employee. These balances will be confirmed and certified with the department head, office holder, and individual employee.

All vacation for full-time employees will accrue forward in the following format.

- On the six-month anniversary date- One week, not to exceed forty (40) hours.
- First year anniversary date- One week, not to exceed forty (40) hours.
- Years two through four (2-4) on the anniversary date- Two weeks, not to exceed (80) hours.
- Year five (5) and forward on the anniversary date- Three weeks, not to exceed one hundred twenty (120) hours

Part-time and temporary employees do not qualify for nor accrue any vacation leave.

After the first six months of employment, upon separation of full-time employment, balances shall be prorated forward from the most recent anniversary date until the separation date.

At the employee's request, upon separation, accumulated vacation hours or a portion thereof can be converted to sick hours in lieu of a payout.

<u>Accumulation of Vacation Time</u>- Accumulated vacation time may be carried forward for up to six weeks (not to exceed 240 hours) at the end of any fiscal year. Any amounts in excess of six weeks (or 240 hours) at the end of any fiscal year will automatically be rolled over to sick time. Employees may not carry a negative balance at any point.

Any full-time employee hired within the past twelve months of the adoption of this policy and their six-month anniversary date has passed will be credited for one week, not to exceed forty (40) hours of vacation time.

2207-03 A RESOLUTION DECLINING TO RAISE THE LOCAL OPTION SALES TAX PURSUANT TO THE PORTLAND ORDINANCE REQUEST

WHEREAS, the city of Portland has passed an ordinance seeking to raise the sales and use tax in the city of Portland from 2.25% to 2.75% and have requested a referendum to approve the ordinance; and

WHEREAS, by state statue, if a city passes an ordinance to increase local option sales tax above the county rate, the city ordinance must be suspended for forty days in order to allow the county legislative body to consider a similar increase which if passed would suspend the city ordinance; and

WHEREAS, this body, having been properly notified of the actions of the city of Portland must act first to express its desire to consider this increase for Sumner County.

THEREFORE, BE IT RESOLVED, by the Sumner County Commissioners meeting in regular session on this the 18th day of July 2022 that this body declines to seek a county wide increase of the local option sales and use tax; and

WHEREAS, Law Director, Leah May Dennen ("Dennen") has announced that after almost 27 years with Sumner County; and almost 18 years as Law Director, she plans to retire August 19, 2022, and

WHEREAS, it is in the best interest of Sumner County that a path be designed that would provide continuity, stability and limit the interruption of legal services to the county, its officials, departments and citizens; and

WHEREAS, there are several active matters that are nearing trial or conclusion and the most prudent action would be for Dennen to continue to oversee the conclusion of these matters along with any expert, outside legal assistance or advisor that is presently involved with the matters; and

WHEREAS, the staff of the Law Director's office "(Staff") is experienced and well trained to handle the day to day workings of the office from the handling of abandoned bodies to committee organization, public notices, resolution drafting, tax inquiries, public records requests and countless other matters and therefore should remain employed to organize and provide orderly transition of the workload of the Law Director's Office; and

WHEREAS, Dennen should be engaged to provide transition services to the County and new legal staff hired by the new Sumner County Commission and County Mayor.

THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session in this the 18th day of July 2022, that this body does negotiate and agree to the following Exit Agreement ("Agreement") with Dennen in order to act in the best interest of the County, staff, elected officials, departments and citizens; and

BE IT FURTHER RESOLVED that even though Dennen has twenty-eight months left on her term and contract, she has chosen to retire and forgo the salary and benefits to be paid to her; however, Dennen understands the need to do what is in the best interest of the county as it relates to ongoing litigation, historical knowledge, uncompleted projects and the ethical standards of a lawyer and she and this body agree to the following terms are set forth below:

A. Dennen's last day in the county offices shall be Friday, August 19, 2022, but she shall continue until December 31, 2022 to answer calls and correspondence from county officials and to assist with the training of a new law director; and

B. Dennen shall continue to supervise, oversee necessary legal decisions, shepherd ongoing items to conclusion or resolution and participate in litigation and/or pending claims filed on or before August 19, 2022 until the matter(s) reach conclusion or she can ethically and in the best interest of the county seek to withdraw from the matter; and

C. All matters pending as of August 19, 2022 and before, which have already been assigned, where necessary, to outside counsel or independent

experts, shall remain with that outside third party until conclusion as such would be in the best interest of the County.

Outside counsel or independent experts shall submit their monthly invoices to the Office of Risk Management and after review by Dennen, these invoices shall be forwarded to the Finance Department for payment; and

D. Dennen shall be paid her regular salary through August 31, 2022 and remain a full-time employee. On or before August 31, 2022, Dennen shall be paid a final payment representing, her contractual salary from September 1, 2022 to December 31, 2022, but as of September 1, she shall no longer be a full-time county employee, but a retiree, eligible for any benefits due her under such status.

Until, December 31, 2022, Dennen shall continue her contractual duties set forth herein.
