MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS JULY 17, 2023

The Board of County Commissioners of Sumner County, Tennessee met in regular session on Monday, July 17, 2023, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Merrol N. Hyde. Also present were the County Clerk Carolyn Templeton, County Mayor John C. Isbell, Law Director Eric Sitler and Staff Attorney Steve Weiner, and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Sheriff Sonny Weatherford. Chairman Merrol Hyde noted that with twenty-four members seated, a simple majority would be by thirteen votes; and that matters requiring a twothirds vote would be by sixteen votes during this session.

The Invocation was led by Commissioner Baker Ring.

The Pledge of Allegiance was led by the County Clerk, Carolyn Templeton.

APPROVAL OF AGENDA

Commissioner Harris moved, seconded by Commissioner Miller, to adopt the agenda as amended. The Commission unanimously approved the agenda by voice vote of the body.

RECOGNITION OF THE PUBLIC

Chairman Hyde opened the floor to allow the public to speak concerning any matter on the agenda.

Jean Montgomery of 1036 Prestwick Lane, Gallatin spoke about the Tourism Board and expressed concerns about Resolution 2307-12.

Zoe Greene of 111 Millers Pt, Gallatin, Executive Director of Tourism shared about her education and data about collected occupancy tax. She asked for clarity on the purpose of the resolution.

Wayne Drown of 1120 N Corinth Road, Portland expressed his support for Resolution of Resolution 2307-11. He discussed the low volume/low pressure and lack of infrastructure in the northern part of the County. Also discussed the problems the volunteer fire departments face due to hydrants with low volume/low pressure.

Corbin Keen of 815 Lear Road, Portland spoke in favor of Resolution 2307-11. He discussed the lack of water taps available due to lack of water.

Kevin Baigert of 424 AB Wade Road, Portland, stated he is on the fence about Resolution 2307-11 and expressed his concerns with development in the northern part of the county. He spoke in favor of Resolution 2307-12 and would like to revamp the whole operation. He also questioned the appointment of EMS Chief.

Mike Callis of 221 Westland, Portland, Mayor of Portland, spoke in support of Resolution 2307-12 and the benefits the improved infrastructure would bring to the areas. He asked the Commission for their help and support.

John McCloud of 195 Oak Drive, Portland, spoke in favor of Resolution 2307-12 and stated the need for the water lines to fix the volume and pressure.

Renea Allen of 390 Rogues Fork Road, Bethpage, spoke against the process used to bring forward the recommendation for the new EMS Chief. She also spoke against the appointment of John Michael Poss as the EMS Chief and gave her resignation from EMS.

John Bradley of 704 South Broadway, Portland, City Attorney for Portland and Westmoreland, spoke in favor of Resolution 2307-12 and stated uncontrolled growth is not a problem in Portland or Westmoreland. He asked for the Commission to approve without conditions.

Bryan Price of 865 Coker Ford Road, Portland, Utilities Director for City of Portland, spoke in support of Resolution 2307-12. He gave a brief overview of study completed and details of the plan.

With no one else wishing to speak on regular agenda items, recognition of the public was closed.

Organization:

The Tourism Board shall be organized as a nine (9) member Body ("New Formula"), and this resolution shall reconfigure the makeup of the Tourism Board and rescind any previous conflicting resolutions passed by the body. All new members shall be appointed and elected by the County Commission in the following manner:

A. Four (4) members from citizens residing in Sumner County; and,

B. Four (4) members from among the members of the Sumner County Commission; and,

C. One (1) member from a City Chamber of Commerce within Sumner County to be rotated by City every year beginning with White House Chamber of Commerce then on to Westmoreland Chamber of Commerce, Portland Chamber of Commerce, Hendersonville Chamber of Commerce, Gallatin Chamber of Commerce, and Goodlettsville Chamber of Commerce.

Election:

Any members elected after the passage of this resolution shall be appointed and elected by the County Commission using the New Formula. **Terms:**

A. After the appointment and confirmation of a new citizen member, their membership will commence on September 1st of the appointment year and continue for a period of two (2) years, terminating on August 31st at the end of that term not to exceed two terms.

B. The term of any member designated from the County Commission shall be coterminous with such member's then term as a member of the County Commission commencing on September 1st of the appointment year.

C. The term of Chamber of Commerce Member shall be one (1) year not to exceed one term beginning September 1st of the appointment year, which shall rotate through as outlined in subpart "C" in the Organization section above.

BE IT FURTHER RESOLVED The Executive Director shall be appointed and elected by the County Commission; and

BE IT FURTHER RESOLVED All presently elected citizen members of the Tourism Board shall remain seated until the expiration of their present term, either by time, resignation, or removal from office; and

BE IT FURTHER RESOLVED this Resolution replaces Resolution 1710-03 from October 16, 2017; and

BE IT FURTHER RESOLVED that any previous resolutions of this body in conflict with this resolution are hereby repealed; and

BE IT FURTHER RESOLVED that this resolution shall become effective upon passage, the public welfare requiring it.

WHEREAS, The 2023 competitive portion of the Tennessee Department of Environment and Conservation (TDEC) State Water Infrastructure Grant (SWIG) program has a maximum award of \$20,000,000 for regional water projects; and

WHEREAS, The competitive SWIG monies are intended to modernize, improve, and strengthen water infrastructure on viable projects that can be completed before the end of 2026 that support criteria such as the following: a. Provide safe and reliable drinking water for existing homeowners and county residents through collaborative efforts,

b. Provide resilient infrastructure for extreme weather events,

c. Support strategic investments in water system challenges for existing homeowners and county residents; and

WHEREAS, Sumner County, the City of Gallatin, the City of Westmoreland, the Castalian Springs-Bethpage Water Utility District, and the City of Portland seek to apply for the maximum amount allowed within the TDEC grant guidelines in a collaborative effort to help update aging infrastructure, offer drought mitigation, expand opportunities for fire hydrants, and provide interconnectivity in order to provide safe drinking water during natural disasters and other catastrophic events within the region; and

WHEREAS, Sumner County has experienced intense growth in the past decade, including in the cities of Gallatin, Westmoreland, and Portland ("Cities"); and

WHEREAS, this growth is frequently accomplished through the annexation of unincorporated areas of the county which are situated adjacent to these Cities; and

WHEREAS, the Sumner County Commission believes this grant could facilitate additional development pressure; and

WHEREAS, unrestrained growth through annexation increases financial burdens upon the taxpayers of Sumner County.

NOW, THEREFORE, BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on this the 17th day of July, 2023, that this body does hereby support and authorize that application be made for a Competitive TDEC Water Regionalization SWIG Program Grant in conjunction with the above-mentioned area partners; and

BE IT FURTHER RESOLVED that the approval of the disbursement of grant funds by the county for this project shall be conditioned on the Cities creating a minimum of a five (5) year moratorium on annexation of unincorporated areas of the county for purpose of residential development; and
