MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS SEPTEMBER 18, 2023

The Board of County Commissioners of Sumner County, Tennessee met in regular session on September 18, 2023, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Merrol N. Hyde. Also present were the County Clerk Carolyn Templeton, County Mayor John C. Isbell, Law Director Eric Sitler and Staff Attorney Steve Weiner, and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Sheriff Sonny Weatherford. Chairman Merrol Hyde noted that with twenty-two members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session. Commissioners Moss and Pomeroy were not present.

RECOGNITION OF THE PUBLIC

Chairman Hyde opened the floor to allow the public to speak concerning any matter on the agenda.

Judge Ron Blanton, General Sessions Judge, 103 William Shy Drive spoke against Resolution 2309-13 after explaining the two-month notice would not work for Recovery Court and would cause the program to shut down.

Laura Baigert of 424 AB Wade Road, Portland presented presentation boards with information about previous and current funding of SRO positions and expressed support for law enforcement but concerned with the many unanswered questions and costs.

Charlena Aumiller of 424 Ruland Circle, Hendersonville spoke against Resolutions 2309-11, 2309-13 and 2309-16. Expressed no concerns with looking into the use of solar if it does not delay the repair of the jail roof. Also spoke against Resolution 2309-14 and in support of keeping the books in schools.

Kay Brooks of 123 Trousdale, Hendersonville spoke against inappropriate books in schools and in support of Resolution 2309-14.

Kevin Baigert of 424 AB Wade Road, Portland expressed support for law enforcement and against unnecessary property tax increases.

With no one else wishing to speak on regular agenda items, recognition of the public was closed.

DELINQUENT TAX SALE

Chairman Hyde introduced the following resolution:

2309-06 A RESOLUTION OF THE COMMISSION OF SUMNER COUNTY, TENNESSEE, CONCERNING TAXES AND THE DISPOSAL OF REAL PROPERTY OWNED BY SUMNER COUNTY.

WHEREAS, Sumner County prosecutes delinquent taxes in Sumner County Chancery Court and that Court orders the auctioning of certain properties to enforce the tax lien of Sumner County as provided by Tennessee Code Annotated § 67-5-2101; and

WHEREAS, real property acquired by Sumner County in delinquent tax sale(s) remains encumbered by the liens of the delinquent taxes owed to Sumner County that were not paid as a result of the auction; and

WHEREAS, Tennessee Code Annotated § 67-5-2507(b)(3) allows a county legislative body to authorize the sale of properties acquired by the county for less than the taxes owed if it is impracticable to sell such property for the full amount of the taxes, penalties, costs and interest; and

WHEREAS, the Sumner County Law Director acting as Delinquent Tax Attorney is responsible by law for the sale of such surplus properties; and

WHEREAS, it is in the public interest that real property acquired by Sumner County and encumbered by Sumner County taxes be offered for sale in the most streamlined manner possible;

WHEREAS, the County Commission Delinquent Tax Committee has found the Jason Court Property, Map and Parcel Number 135B-A-008.00 cannot be sold for the amount of taxes owed; and

NOW, THEREFORE, BE IT RESOLVED BY COMMISSION OF SUMNER COUNTY AS FOLLOWS:

1. The Sumner County Law Director is hereby authorized to dispose of the Jason Court property, Map and Parcel Number 135B-A-008.00, hereto for an amount less than the taxes owed on such properties.

2. At the time of such sale(s), pursuant to T.C.A. 67-5-2508(d), all County and City taxes not realized from the proceeds of such sale shall be waived, and the proceeds shall be divided between the County and the City on a pro-rata basis.

3. The Law Director shall use the most cost effective and streamlined process available, to include, but not be limited to an RFP, a transfer to another governmental entity, a negotiated sale, a public surplus auction or such other sale as may be authorized.

4. This Resolution is to take effect from and after its passage, the public welfare requiring it.

Upon motion of Commissioner Harrison, seconded by Commissioner Miller, the Commission voted unanimously by voice vote to approve Resolution 2309-06.

WHEREAS, the employees of the Sumner County government are promised a decent, fair, and respectable workplace environment; and

WHEREAS, the maintenance of such workplace conditions remains a top priority of the Sumner County government; and

WHEREAS, an outlined set of practices for Sumner County employees who wish to either establish or escalate a complaint against a fellow employee delivers a clear path for resolution; and

BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on this the 18th day of September 2023, consistent with Tennessee Code Annotated, that this body does hereby approve the practices for Sumner County employees to introduce and escalate employee complaints attached herein:

Complaints Against a Subordinate Employee or Employee of Equal Authority:

Any Sumner County employee who wishes to file a complaint against a subordinate or employee of equal authority is to direct their complaint to their immediate supervisor. Said supervisor is to review the complaint, weigh its merits, and either mediate a resolution, take appropriate action, or, if applicable, escalate the complaint to their supervisor.

Complaints Against an Immediate Supervisor

Any Sumner County employee who wishes to file a complaint against their immediate supervisor is to direct their complaint to the supervisor of the person to whom the employee has a complaint. The receiving party is to review the complaint, weigh its merits, and either mediate a resolution or take appropriate action.

Complaints Against Other Supervisory Staff

Any Sumner County employee who wishes to file a complaint against any supervisory staff who is not their direct supervisor is to direct their complaint to their department head or the responsible elected official, whichever is appropriate. The receiving party is to review the complaint, weigh its merits, and either mediate a resolution or take appropriate action.

Complaints Against an Official

Any Sumner County employee who wishes to file a complaint against the elected or appointed official presiding over their department is to direct their complaint to the Office of the Law Director. The Law Director is to review the complaint, weigh its merits, and choose to mediate a resolution or, no more than ninety days after receiving the complaint, notify the Sumner County Ethics and Conduct Committee of their findings for appropriate action to be taken.

Complaints Against the Law Director

Any employee in the Office of the Law Director who wishes to file a complaint against the Law Director is to direct their complaint to the Chair of the Sumner County Commission. The Chair is to review the complaint, weigh its merits, and either recommend a path for mediation or, no more than ninety days after receiving the complaint, present their findings to the County Commission for appropriate action to be taken.

Escalation by an Aggrieved Employee

Should an employee, having taken and documented steps taken to resolve an issue, not find redress for a particular complaint, that employee may take their issue to the Law Director's Office.

BE IT FURTHER RESOLVED that this policy is to replace any prior resolutions or departmental policies dictating the procedures for introducing or escalating a complaint against another Sumner County employee.

After discussion, Commissioner Wynne moved, seconded by Commissioner Ring, to send the resolution back to the Legislative Committee.

NOW THEREFORE BE IT RESOLVED, the Sumner County Board of Commissioners meeting in regular session on the 18th day of September 2023 requires the Sumner County Grant Writer, prior to the beginning of the grant applications process, to present to the appropriate committee all available information for all grants which the grant writer will begin the process of application in the following month; and

BE IT FURTHER RESOLVED, that any grant applied for without going through the prior review process shall not be considered for approval by the County Commission excepting for good cause shown beyond the control of the grant writer; and

BE IT FURTHER RESOLVED, that the County Commission declares that poor planning does not constitute good cause.

Commissioner Mansfield explained the revised resolution placed on desks before the meeting with additional language that should satisfy Judge Blanton's concerns.

After explanation, Commissioner Mansfield moved, seconded by Commissioner Teachenor, to amend to add the following language to the resolution. WHEREAS, children are our greatest treasure, and our most vulnerable population. We must always weigh the risk of harm to children in public policy decisions; and

WHEREAS, we value integrity and excellence and will not trade the innocence of children for other governmental goals; and

WHEREAS, protecting the innocence of children should be an issue of concern for all adults; and

WHEREAS, adults and children are increasingly overtly sexualized in our nation, state, and county; and

WHEREAS, according to a recent Tennessee Department of Health report titled "Sexual Violence" there were 4,582 victims of sexual assault in the Mid-Cumberland Region from 2016 to 2020 with 2,737 of those cases (59.7%) being under the age of 18; and

WHEREAS, according to the Tennessee Bureau of Investigation the average age of a child sold for sex is 13 years old and human trafficking is the second-fasting growing criminal industry; and

WHEREAS, the exposure to and normalization of sexualized behaviors reduces children's inhibitions and ability to protect themselves from the sexual advances of others; and

WHEREAS, children learn from observing and subsequently acting out the behaviors they have observed. Children who have observed sexualized behaviors or who have been the victim of sexual assault may act out with other children at home or school, which may lead to additional child victims; and

WHEREAS, the normalization of sexualized behaviors and content to children is not in the long-term interest of children or society. Wholesome, good, and honorable content and activities should be promoted to children instead.

NOW THEREFORE BE IT RESOLVED, the Sumner County Board of Commissioners meeting in regular session on the 18th day of September 2023 is committed to protecting the innocence of children, and to cultivating healthy children, families, communities, and institutions; and **BE IT FURTHER RESOLVED**, no county staff or resources shall be allocated to activities, programs, events, content, or institutions which support, normalize, or encourage the sexualization of children and youth; and

BE IT FURTHER RESOLVED, that this resolution applies to the extent that it does not conflict with Tennessee law; and

BE IT FURTHER RESOLVED, the Board encourages individuals and communities to promote the good and the honorable to children rather than the normalization of sexual behaviors, protecting the health and wellbeing of our children and the future of our county; and

BE IT FURTHER RESOLVED that the Chairman of the Sumner County Commission is directed to establish an ad-hoc committee to study and, as appropriate, make recommendations to the Sumner County Commission to address the threat of sexualization of children in Sumner County in accordance with "Exhibit A" attached hereto.
