MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS OCTOBER 23, 2023

The Board of County Commissioners of Sumner County, Tennessee met in regular session on October 23, 2023, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Merrol N. Hyde. Also present were the County Clerk Carolyn Templeton, County Mayor John C. Isbell, Law Director Eric Sitler and Staff Attorney Steve Weiner, and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Sheriff Sonny Weatherford. County Mayor Isbell introduced the following Proclamation:

A PROCLAMATION DECLARING THE MONTH OF NOVEMBER FAMILY COURT AWARENESS MONTH

WHEREAS, the mission of Family Court Awareness Month (FCAM) is to increase awareness on the importance of a family court system that prioritizes child safety and acts in the best interest of children, and;

WHEREAS, the mission at FCAM is fueled by the desire to create awareness and change in the family court system for the conservatively

estimated, 58,000 children a year ordered into unsupervised contact with physically or sexually abusive parents, while honoring the hundreds of children who have been reported as murdered during visitation with a dangerous parent, and;

WHEREAS, the mission of FCAM is to increase awareness on the importance of empirically-based education and training on domestic violence, childhood trauma, child sexual abuse, coercive control, post separation abuse for all professionals working on cases within the family court system, and;

WHEREAS, the mission of FCAM is to increase awareness on the importance of using scientifically valid, evidence-based, treatment programs and services that are proven in terms of safety, effectiveness, and therapeutic value, and;

WHEREAS, the mission at FCAM is to educate judges and other family court professionals on evidence-based, peer-reviewed research. Such research is a critical component to making decisions that are truly in the best interest of children. This research includes CDC Study: The Adverse Childhood Experiences Study; National Institute of Justice funded Study: Child Custody Evaluators' Beliefs About Domestic Abuse Allegations ; and The GW Law School, Institute of Justice funded Study: Child Custody Outcomes in Cases Involving Parental Alienation and Abuse Allegations

NOW, THEREFORE, I, John C. Isbell, Mayor of Sumner County, Tennessee hereby declare the month of NOVEMBER to be FAMILY COURT AWARENESS MONTH.

I encourage all residents to support their local communities' efforts to prevent the harm of children in the hands of family members and to honor and value the lives of children.

WHEREAS, School Resource Officers (SROs) play a crucial role in maintaining a safe and conducive learning environment by providing security, mentorship, and support to students, faculty, and staff; and

WHEREAS, the availability of adequate funding for SRO programs ensures that schools can benefit from the presence of trained law enforcement professionals who can respond effectively to emergencies and contribute positively to the school community; and

WHEREAS, consistent and permanent funding for SRO programs is essential for County governments to make long-term financial plans and commitments to ensure a continuous and stable SRO presence; and

WHEREAS, Public Chapter No. 367 comprehensively addresses vital aspects of school safety, encompassing safety plans, security systems, annual drills, security assessments, and training requirements for armed security personnel; nevertheless, it notably lacks a mandatory provision for securing permanent funding dedicated to School Resource Officers (SROs) in educational institutions; and

WHEREAS, the Endowment Grant Contract for the Statewide School Resource Officer (SRO) Grant Program shall take effect on July 01, 2023, and shall remain in force only for a duration of twelve (12) months from the effective commencement date (hereinafter referred to as the "Term"), with the State holding no responsibility to the Grantee (Sumner County) for any grant-related commitments beyond the specified Term; and

WHEREAS, enshrining SRO funding within the state code will provide a clear and enduring framework for supporting these vital programs, allowing for

efficient and recurring allocation of resources and sustained investment in our schools' safety.

WHEREAS, if the state should withdraw SRO funding, the County would continue to be bound by the maintenance of effort obligations associated with the acceptance of said funds, thereby continuing the County's maintenance of effort requirements without a funding source, potentially necessitating property tax increases; and

NOW, THEREFORE, BE IT RESOLVED by the Sumner County Board of Commissioners meeting in regular session on the 23rd day of October, 2023 that:

1. We strongly urge the State General Assembly to codify legislation that permanently includes funding for School Resource Officers (SROs) as a mandatory provision within the state code and we specifically request the Sumner County legislative delegation to carry such legislation.

2. We strongly urge the State General Assembly to enact legislation that would release the County from the maintenance of effort obligations tied to the acceptance of said funds in the event of State funding discontinuation, thus reducing the County's maintenance of effort requirements and we specifically request the Sumner County legislative delegation to carry such legislation.

We believe that this step is necessary to ensure the continued safety and security of our educational institutions and the overall well-being of our students.
 We call upon our elected representatives to prioritize the passage of such pieces of legislation, recognizing the critical importance of SRO programs in fostering a secure and nurturing learning environment.

5. We further request that this resolution be communicated to the State General Assembly and relevant state officials, highlighting our community's commitment to the safety and welfare of our students and schools.

A RESOLUTION FOR A BROADBAND READY COMMUNITY

Section 1. As used in this chapter, "permit" means any local permit, license, certificate, approval, registration, or similar form of approval required by policy, administrative rule, regulation, or ordinance with respect to a project. Section 2. As used in this chapter, "project" means the construction or deployment of wireline or wireless communications facilities to provide communications services in a unit.

Section 3: Notwithstanding any other provision of Sumner County's ordinance, the following shall apply to a project:

(1) Sumner County, Tennessee will:

(A) Adopt an efficient and streamlined policy for reviewing applications and issuing permits related to projects relative to broadband services.

(B) Appoint a single point of contact in the Sumner County for all matters related to a broadband project;

(C) Establish procedures to allow all forms, applications, and documentation related to a project be reviewed and either approved or denied within thirty (30) business days after the application is submitted; and to allow the project to be filed or submitted and signed by electronic means, where possible;
 (2) Sumner County will not:

(A) Require an applicant to designate a final contractor to complete a project;
 (B) Impose an unreasonable fee for reviewing an application or issuing a permit for a project. The fee will not exceed one hundred dollars (\$100);

(C) Impose a seasonal moratorium on the issuance of permits for projects; and (D) Discriminate among communications services providers or utilities with respect to any action related to a broadband project, including granting access to public rights-of-way, infrastructure and poles, and any other physical assets owned or controlled by the political subdivision.

(3) Sumner County acknowledges that:

(A) Tennessee Certified Broadband Ready Community has an affirmative duty to notify the Tennessee Economic and Community Development Department (TNECD) of any changes to the information submitted as part of its application.
(B) Failure to notify TNECD of changes may result in revocation of Sumner County's Broadband Ready Certification.

Section 4. This ordinance shall take effect immediately upon adoption by the governing body upon passage, the public welfare requiring.

• The column, Recom Rate, is the recommended rate.

• The column, Costs, is the employee's annualized increase, followed by the related benefits and a sub-total (A).

• The column, ARPA Reclass, is the annualized costs of the ARPA supplements to be reclassified to local funding, followed by the related benefits and a sub-total (B).

• The column, Total, is the total annualized cost by the employee.

• The Commission recognizes that employees turn over or move positions and that data may not be 100 percent accurate. Therefore, the Commission allows adjustments for earlier stated variances.

• The adjustments are effective October 23, 2023 – no retroactive payments.
