## MINUTES SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS FEBRUARY 26, 2024

The Board of County Commissioners of Sumner County, Tennessee met in regular session on February 26, 2024, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:00 p.m. Present and presiding was the Chairman Merrol N. Hyde. Also present were the County Clerk Carolyn Templeton, County Mayor John C. Isbell, Law Director Eric Sitler and Staff Attorney Steve Weiner, and the following Commissioners to wit:

Having a duly constituted quorum, the meeting was opened in due process by Sheriff Deputy Helson. Chairman Merrol Hyde noted that with twenty-one members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session. Commissioners Becker, Pomeroy and Sullivan were not present.

WHEREAS William I. Brown survived his wife. Martha Brown: and

**WHEREAS** William I. Brown died testate leaving a Last Will and Testament executed October 1, 2015; and

WHEREAS William I. Brown made and published Codicil Number 1 to his Last Will and Testament on March 17, 2016; and

**WEHREAS** William I. Brown completely rewrote the specific distribution provisions of his Last Will and Testament in Codicil Number 1 by leaving a specific bequest in the sum of Five-Hundred Thousand Dollars and No Cents (\$500,000.00) to Sumner County to be kept in a restricted fund for the exclusive purpose of the "establishment, promotion, ongoing support, and maintenance of the William and Marth Brown Park" at 212 Hunters Lae, Hendersonville, Tennessee; and

WHEREAS William I. Brown completely rewrote the residuary clause of his Last Will and Testament in Codicil Number 1 by leaving the rest, residue, and remainder of his estate to the William and Martha Brown Education Technology Trust for the purpose of assisting Sumner County public schools with technology needs; and

**WHEREAS** the funds Mr. brown specifically left to the County for the purposes of establishing and maintaining the William and Martha Brown Park were inadvertently distributed to the William and Marth Brown Education Technology Trust contrary to the terms of Codicil Number 1.

**NOW BE IT RESOLVED** by the Sumner County Board of County Commissioners meeting in regular session on this the 26<sup>th</sup> day of February, 2024, that this body does hereby establish a county park at 212 Hunters Lane to be called the *William and Martha Brown Park*; and

**BE IT FURTHER RESOLVED** that the Sumner County Commission directs the Trustees of the William and Martha Brown Education Trust to transfer, plus any accrued interest, Five-Hundred Thousand and No Cents (\$500,000.00) mistakenly distributed to said Trust to Sumner County, Tennessee to be held in a restricted fund by the Sumner County Finance Department for the exclusive purpose of the "establishment, promotion, ongoing support, and maintenance of the William and Martha Brown Park" to be located at 212 Hunters Lane, Hendersonville, Tennessee in accordance with the last wishes of William I. Brown.

**WHEREAS** industrial development is defined by the Act as "the development of any property for use by any person in a business classified as industrial under the United States Government Standard Industrial Classification Manual:" and

WHEREAS the United States Government Standard Industrial Classification Manual lists ten categories of industrial classification, to-wit: A) Agriculture, Forestry, and Fishing, B) Mining, C) Construction, D) Manufacturing, E) Transportation, Communications, Electric, Gas, and Sanitary Services, F) Wholesale Trade, G) Retail Trade, H) Finance, Insurance, and Real Estate, I) Services, and J) Public Administration;

WHEREAS Resolution 0704-04 was passed in April of 2007; and

**WHEREAS** Resolution 0704-04 defined Industrial and Residential as the same as the definitions set forth in the Sumner County Zoning Resolution; and

WHEREAS the Act defines Industrial and Residential in the Act itself; and

**WHEREAS** the definitions of Industrial and Residential in the Act are clear and unambiguous; and

**WHEREAS** the County Commission cannot unilaterally change the Act without amending the Act through the Private Act approval process, which includes involvement of the Tennessee General Assembly.

**NOW THEREFORE BE IT RESOLVED** by the Sumner County Board of County Commissioners meeting in regular session on this the 26<sup>th</sup> day of February 2024, that this body does hereby **repeal** and **rescind** Resolution 0704-04; and
