MINUTES SPECIAL CALLED SUMNER COUNTY BOARD OF COUNTY COMMISSIONERS AUGUST 12, 2024

The Board of County Commissioners of Sumner County, Tennessee met in special called session on August 12, 2024, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 6:00 p.m. Present and presiding was the Chairman Merrol N. Having a duly constituted quorum, the meeting was opened in due process by Sheriff's Chief Deputy Eric Craddock. Chairman Merrol Hyde noted that with twenty-two members seated, a simple majority would be by thirteen votes; and that matters requiring a two-thirds vote would be by sixteen votes during this session. Commissioners Boyt and Harris were not present.

The Invocation was led by Commissioner David Klein.

The Pledge of Allegiance was led by the County Clerk, Carolyn Templeton.

APPROVAL OF AGENDA

Commissioner Mansfield moved, seconded by Commissioner Klein, to sever the county general and school budgets with county budget to be heard first. Chairman Hyde ruled the motion carried by voice vote of the body. Commissioner Ring challenged the ruling. Chairman Hyde called for a roll call vote. Chairman Hyde declared the motion to sever approved by the body.

Commissioner Rogers moved, seconded by Commissioner Klein, to adopt the agenda as amended. The Commission unanimously approved the agenda by voice vote of the body.

RECOGNITION OF THE PUBLIC

Chairman Hyde opened the floor to allow the public to speak concerning the matter on the agenda.

Ruth Fennell of 1049 Blue Jay Way, Gallatin spoke in support of pay increases for teachers and staff and stated repairs to the stadiums should be completed in stages using funds that are already available.

Pascal Jouvence of 1335 Long Hollow Pike, Gallatin was not present.

Stephen Sanders of 126 Mansker Park Drive, Hendersonville expressed his support for funding for the stadium projects.

Greg Arias of 820 Harden Street, Gallatin spoke in support of funding the stadium projects.

Kevin Rector of 113 Stoddard Street, Gallatin expressed his support for funding of the stadium projects.

Jay Ingrum of 755B Newton Lane, Gallatin spoke in support of funding the stadium projects.

Charles Hagood of 225 S. Thompson Lane, Goodlettsville spoke in support of funding the stadium projects and asked the Commissioners for approval.

Kevin Baigert of 424 AB Wade Road, Portland spoke in support of the \$7.5 million for teacher and staff pay increases and against \$5.4 million for stadium projects.

Jo Swafford of 1102 Kimberly Drive, Goodlettsville spoke in support of funding for stadium projects.

Gracie Oliver of 104 Liberty Court, Hendersonville expressed support for funding of the stadium projects and pay increases for teachers and staff.

Scott Langford of 1260 Twelve Stones Crossing, Goodlettsville, Director of Sumner County Schools thanked the Commissioners for their work and expressed his appreciation to Commissioner Shoaf for working together to find a way to meet the needs of the community. He explained \$28.9 million for teacher and classified employee pay increases along with \$27.4 million in capital are included in this budget, with no tax increase.

Charlena Aumiller of 143 Ruland Circle, Hendersonville spoke in support of funding the stadium projects.

Chris Shoemaker of 1018 Silver Maple Lane, Portland asked for a \$2,500.00 refund for the Highland VFD for application fees already paid and a waiver of any additional fees related to the construction of their new building. He also spoke to the wheel tax exemption for disabled veterans.

With no one wishing to speak on regular agenda items, recognition of the public was closed.

REPORT OF CHAIR

Chairman Hyde commended and expressed his appreciation to the Commissioners on the hard work that has been done. He also explained there was a hard rule in the County that they would not build any athletic facilities, but the door was opened when Station Camp High School was built to include the football stadium.

RECESS

Chairman Hyde declared recess at 7:00 p.m. The meeting reconvened at 7:11 p.m.

BUDGET HEARINGS/PUBLIC HEARINGS

Commissioner Shoaf explained there are three departments that requested another budget hearing and called for a representative for the libraries, no one was present.

Circuit Court Clerk Kathryn Strong requested a budget amendment in the amount of \$35,446.00. She explained the personnel line was cut by \$21,446.00 and asked for it to be added back to allow for raises comparable to other county offices. She further explained a \$4,000.00 increase cost in phone expenses due to the new phone system and the need for a \$10,000.00 transfer for data services.

Planning and Engineering Director Josh Suddath requested to keep Grants Administrator Kim Norfleet in his office instead of moving the position to the Finance Department.

Commissioner Shoaf called for the Assessor of Property; County Mayor John Isbell announced Mr. Linville was out of town and stated he was asked to speak on his behalf. Mr. Isbell went on to explain the request for pay parity for the clerks and fieldman and the need to bring them up to the market adjustment and asked for a \$35,000.00 increase.

ECC Director Michael Guthrie asked for \$2,636.00 for the QA Supervisor position.

Commissioner Shoaf called for a representative from the Election Commission, no one was present.

Chairman Hyde declared the hearings closed with no one else wishing to speak.

RESOLUTIONS

Commissioner Shoaf introduced the following resolution. Commissioner Mansfield moved for approval, seconded by Commissioner Klein.

2408s-01 A RESOLUTION FIXING THE TAX LEVY IN SUMNER COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 2024, AND ENDING JUNE 30, 2025

BE IT RESOLVED by the Sumner County Board of County Commissioners meeting in regular session on this the 12th day of August 2024, that the property tax rate for Sumner County, Tennessee for the fiscal year beginning July 1, 2024, and ending June 30, 2025, shall be \$1.4210 on each \$100 of taxable property, which is to provide revenue for each of the following funds and otherwise conform to the following levies; and

BE IT FURTHER RESOLVED that the County Trustee shall reflect the property tax rate upon receipts used in collecting property taxes; and

BE IT FURTHER RESOLVED that all resolutions of the Sumner County Board of County Commissioners which are in conflict with this resolution are hereby repealed; and

BE IT FURTHER RESOLVED that this resolution shall take effect from and after its passage, and its provisions shall be in force from and after July 1, 2024, the public welfare requiring it.

Chairman Hyde declared Resolution 2408s-01 approved unanimously by voice vote of the body.

Being on the prevailing side, Commissioner Shoaf moved, seconded by Commissioner Becker, to reconsider Resolution 2408s-01 to move one half of one cent from the \$20 million in capital set aside for highway back to the general fund to address some of the changes requested during the budget hearings. Chairman Hyde declared the motion to reconsider approved by voice vote of the body. Commissioner Mansfield abstained from the vote.

Commissioner Shoaf moved, seconded by Commissioner Becker, to move one half of one cent from the \$20 million in capital set aside for highway back to the general fund. Chairman Hyde declared the motion to move one half of one cent from capital to general approved by voice vote of the body. Commissioner Mansfield abstained from the vote. The amendment is reflected in the resolution as presented in the minutes.

Commissioner Shoaf introduced Resolution 2408s-02 and moved, seconded by Commissioner Becker, to amend the county budget to move \$5.4 million to capital with the intent to use for facility funding for Sumner County Schools.

BE IT FURTHER RESOLVED, pursuant to the 2002 Financial Management Act, the 2012 Financial Management Act, and the 1981 Local Optional Law, that if the need shall arise, the budget committee, with the approval of any official, head of any department or division which may be affected, may transfer any amount within any major appropriation category. Also, the approval of the county board of commissioners must be obtained, as required by law, for transfers between major appropriation categories within the same fund.

Aforesaid authorization shall clearly state the reason for the transfer(s), but this provision shall in no case whatsoever be construed as authorizing transfers from one fund to another but shall apply solely to transfers within a certain fund.

BE IT FURTHER RESOLVED that any appropriations made by this resolution, which cover the same purpose for which a specific appropriation is made by statute, are made in lieu of but not in addition to said statutory appropriation. The salary, wages, or remuneration of each officer, employee, or agent of the county shall not be in excess of the amounts authorized by existing law or as set forth in the estimate of expenditures which accompanies this resolution. Provided, however, that appropriations for such salaries, wages, or other remuneration hereby authorized shall in no case be construed as permitting expenditures for an office, agency, institution, division, or department of the county in excess of the appropriation made herein for such office, agency, institution, division, or department of the county. Such appropriation shall constitute the limit to the expenditures of any office, agency, institution, division, or department for the fiscal year ending June 30, 2025. The aggregate expenditures for any item of appropriation shall in no instance be more than the amount herein appropriated for such item.

BE IT FURTHER RESOLVED that the detailed "Sumner County Government Consolidated Annual Budget for the Fiscal Year Ended June 30, 2025" is adopted by reference for line-item detail.

BE IT FURTHER RESOLVED that any resolution which may hereafter be presented to the board of county commissioners providing for appropriations in addition to those made by this budget appropriation resolution shall specifically provide sufficient revenue or other funds, actually to be provided during the fiscal year in which the expenditure is to be made, to meet such additional appropriations.

BE IT FURTHER RESOLVED that there is hereby appropriated for state approved projects such amount or amounts as may from time-to-time be approved by contract with the State of Tennessee Department of Transportation.

BE IT FURTHER REOLVED that the county mayor and the county clerk are hereby authorized to borrow money on revenue anticipation notes, provided such notes are first approved by the director of local finance, to pay for the expenses herein authorized until the taxes and other revenue for the fiscal year 2024-2025 have been collected. The proceeds of loans for each individual fund shall not exceed 60% of the appropriations of each individual fund and shall only be used to pay the expenses and other requirements of the fund for which the loan is made. The loan shall be paid out of revenue from the fund for which money is borrowed. The notes evidencing the loans authorized under this section shall be issued under the applicable sections of Title 9, Chapter 21, Tennessee Code Annotated. Said notes shall be signed by the county mayor and countersigned by the county clerk and shall mature and be paid in full without renewal no later than June 30, 2025.

BE IT FURTHER RESOLVED that the delinquent county property taxes for the year 2023 and prior years and the interest and penalty thereon collected during the year ending June 30, 2025, shall be apportioned to the various county funds according to the subdivision of the tax levy for the year 2023. The clerk and master and the trustee are hereby authorized and directed to make such apportionment accordingly.

BE IT FURTHER RESOLVED that all unencumbered balances of appropriations remaining at the end of the fiscal year shall lapse and be of no further effect at the end of the fiscal year at June 30, 2025.

BE IT FURTHER RESOLVED that the hotel/motel privilege tax shall be set at for the Fiscal Year 2025 at the same percentage as the prior fiscal year.

BE IT FURTHER RESOLVED that courthouse security litigation taxes shall be first appropriated and expended for courthouse security officers' salaries and related benefits.

BE IT FURTHER RESOLVED that any resolution or part of a resolution which has been passed by the board of county commissioners that is in conflict with any provision in this resolution is hereby repealed.

BE IT FURTHER RESOLVED that this resolution shall take effect from and after its passage and its provisions shall be in force from and after July 1, 2024. This resolution shall be spread upon the minutes of the board of county commissioners.

BE IT FURTHER RESOLVED that the appropriations are made subject to the following conditions:

- The non-profit charitable organizations to which funds are appropriated shall file, with the county clerk and the disbursing official, a copy of an annual report of its business affairs and transactions and the proposed use of the county's funds in accordance with rules promulgated by the Comptroller of the Treasury. Such annual report shall be prepared and certified by the chief financial officer of such non-profit organization in accordance with Section 5-9-109(c) of the Tennessee Code Annotated.
- 2) Said funds must only be used by the named non-profit charitable organization in furtherance of their non-profit charitable purposes benefiting the general welfare of the residents of the county.
- 3) All amounts paid to the tourism board are limited to the lesser of the budgeted amount or the hotel/motel tax collections less the applicable trustee's commission.

This resolution shall become effective upon passage, the public welfare requiring it.
