
#### Budget Amendment 2 141-ISM (Westmoreland HS Greenhouse)

The other portion refers to a greenhouse project at Westmoreland HS. The bid returned \$30,000 higher than estimated. This amendment moves funds to cover that amount.



This amendment moves money allocated for capital funds in 76100 to 72620. The transfer covers the expenses related to bleacher and restroom rental for the November playoffs.















Ms. Browning explained they have been advised all grant applications need Commission and School Board approval because it is a joint venture to show a unified front. Grant Accountant Dustin Owens further explained the property is owned by both the County and the School Board and would require approval by both. The State of TN has given funds to MTSU for historic preservation so anything pre-civil war goes before them, and they provide guidance about best practices and preservation. They are considered the leaders of historic preservation with the State of TN.

After discussion, Chairman Mansfield moved, seconded by Comm. Miller, to give the grant money back to the state and forward to the Budget Committee. The motion carried unanimously.

Chairman Mansfield recommended the use of the hospital fund if more than \$500,000.00 is needed for the restoration of the Brown House.



Chairman Teachenor called the regular meeting of the Health and Emergency Services Committee to order with an invocation by Comm. Harris on Monday, January 6, 2025, at 6:03 p.m. in the Sumner County Administration Building. A quorum was present.

#### 3. Approval of Agenda.

Chairman Teachenor moved, seconded by Comm. Jones, to add traffic and safety concerns at intersection of Hunters Lane, Latimer Lane and Wolf Pack Way to the agenda under Report of the Chairman. The motion carried unanimously.

Comm. Rogers questioned why the matter is before the committee when it already passed through the Highway Commission. Law Director Eric Sitler recommended it be brought to this committee due to safety concerns.

Comm. Genung moved, seconded by Chairman Teachenor, to approve the agenda as amended. The motion carried unanimously.

#### 4. Approval of the Minutes of December 2, 2024.

Upon motion of Comm. Rogers, seconded by Chairman Teachenor, the Committee voted unanimously to approve the minutes from December 2, 2024.

#### 5. Recognition of the Public.

Cathy Arlen of 231 Chipaway Drive, Gallatin spoke about a situation with an owner surrender. She also spoke to the previous Animal Control ad hoc and requested a new ad hoc be formed to make changes. She discussed the use of inmate labor at the shelter. Handouts attached.

### Court docs: 4 facing charges after concocting plan to smuggle drugs into jail via the Clermont County Animal Shelter

**CLERMONT COUNTY, Ohio** — Four people have been arrested after concocting a scheme to smuggle in drugs to the Clermont County Jail via the Clermont County Animal Shelter.

The scheme was discovered by police after inmate Vanessa Lee Tudor, 47, was reportedly suspected to be impaired by jail staff.

Upon being drug tested, Tudor's test results soon came back positive for methamphetamines.

Officers with the Clermont County Sheriff's Office then began to review recorded jail calls and text messages that Tudor had recently done in an effort to figure out how Tudor had obtained the drugs.

In the course of their investigation, Tudor was uncovered to have been talking with another inmate, Samantha Cartwright, 45, explicitly about topics relating to drug payments and drug deliveries in their communications.

Upon questioning by police, Cartwright allegedly admitted that she had concocted the plan with Tudor to smuggle in the drugs.

In the scheme, Cartwright reportedly had her husband, Mark Wise, 52, deliver drugs to the Clermont County Animal Shelter. According to court documents, Tudor would then pick up the drugs from the shelter when she was there.

The court documents did not specify why Tudor was at the shelter to be able to pick up the drugs. However, some jails sometimes partner with animal shelters as a form of rehabilitation for inmates to work with their animals.

Video was reportedly obtained by the Clermont County Sheriff's Office that showed Wise making the delivery to the animal shelter.

Tudor, for her part, denied involvement with any plan to buy drugs but could also reportedly not explain to police why she tested positive for methamphetamines.

Tudor faces two counts of conspiracy, one count of illegal conveyance of drugs into a government facility, and one count of aggravated

Cartwright faces two counts of conspiracy and one count of illegal conveyance of drugs into a government facility.

Wise faces two counts of conspiracy, one count of illegal conveyance of drugs into a government facility, one count of aggravated tracking in drugs, and one count of aggravated possession of drugs.

A fourth person, Patricia Weaver, 68, was also arrested in the scheme on two counts of conspiracy and one count of illegal conveyance of drugs into a government facility.

Court documents did not provide further information about Weaver's alleged role in the scheme.

Court documents show that Tudor was already incarcerated on charges of possession of fentanyl, heroin and cocaine.

Cartwright was already incarcerated on three different charges of theft, as well as one charge of passing bad checks.

An initial court date has not yet been set for the four,

### COMPLAINT

Comes the Plaintiff, Amanda Lauren Moore, and for her cause of action against the Defendants would show unto the Court as follows:

### **PARTIES**

- 1. At all relevant times, Plaintiff, Amanda Lauren Moore, was a citizen and resident of Macon County, Tennessee.
- 2. Upon information and belief, Defendant, Jeremy Michael Singleton, is a citizen and resident of Sumner County, Tennessee, and resides at 1060 Kennesaw Blvd., Apt. # 11317, Gallatin, Tennessee 37066.
- 3. Defendant, Sumner County Sheriff's Department, is a governmental entity within the meaning of the Tennessee Governmental Tort Liability Act and is a political subdivision of Sumner County, Tennessee.
- 4. At all relevant times, Jeremy Michael Singleton, was a Sheriff's Deputy employed by the Sumner County Sheriff's Department.

- 5. At all times, Plaintiff, Amanda Lauren Moore, was an inmate at the Sumner County Jail.
- 6. The events leading up to and the injury complained of herein occurred in Gallatin, Sumer County, Tennessee.

### **JURISDICTION AND VENUE**

- 7. This is an action for personal injuries sustained by the Plaintiff, Amanda Lauren Moore as a result of sexual assault and sexual battery by the Defendant, Jeremy Michael Singleton, which occurred during September 7, 2022 through October 26, 2022, and the negligence of Sumner County Sheriff's Department for failing to protect the victim from this sexual predator.
- 8. Jurisdiction and venue are proper in this Court pursuant to Tenn. Code Ann. § 29-20-305 and 308.

### **FACTS**

- 9. On or about September 7, 2022 through October 26, 2022, Amanda Lauren Moore was serving a jail sentence at the Sumner County Sheriff's Department.
- 10. Jeremy Michael Singleton, as an employee of and in the course and scope of his employment with Sumner County Sheriff's Department was a deputy.
- 11. Jeremy Michael Singleton used his position of authority to intentionally and with forethought, sexually assault and sexually batter the Plaintiff.
- 12. During Plaintiff's incarceration, Defendant, Jeremy Michael Singleton, sexually assaulted the Plaintiff by groping, grabbing, inappropriately touching, and kissing the Plaintiff.

  All acts having been performed while Defendant was acting in his capacity as an employee of the Sumner County Sheriff's Department.

- 13. During the Plaintiff's incarceration, she was to be transported as a work trustee to an off-site location from the Jail in Sumner County. Plaintiff was a trustee at an animal shelter in Sumner County. During this transport by the Defendant, he would make unwanted advances and sexually assault and batter the Defendant while in the County vehicle and also while at the animal shelter.
- 14. That the Defendant Singleton was allowed to transport the Plaintiff alone which gave him direct access to sexually assault and batter the Plaintiff.
- 15. Further, Plaintiff was publicly humiliated and embarrassed by other Jailors of the Sumner County Sheriff's Department once she reported the incidents above. After Plaintiff reported the incidents, Sumner County Sheriff's Department had her trustee job changed and moved to a department within the animal shelter where she had to work with Defendant Singleton's girlfriend, who was an employee of the animal shelter.
- 16. The Plaintiff was requested by jailors and Sherrif Department officials to take a pregnancy test in an attempt to embarrass and harass the Plaintiff after she reported the actions of the Defendant.
- 17. That once the Plaintiff reported the actions of the Defendant she was mistreated and harassed by jailors and other staff in the Sumner County Sheriff's Department.
- 18. As a result of the acts of Defendant, Jeremy Michael Singleton, Amanda Lauren Moore was physically violated and suffered emotional trauma. She suffers from permanent and significant physical, emotional, and psychological injuries. Amanda Lauren Moore continues to suffer based upon the actions of the Defendants.
- 19. That upon information and belief, the Defendant Singleton was allowed to transport the female Plaintiff alone and without supervision. That Defendant Singleton transported the

Plaintiff in an automobile owned by the Sumner County Sheriff's Department and / or Sumner County.

20. Upon information and belief, this has happened to other female inmates by other employees of the Defendant, Sumner County Sheriff's Department. That Defendant, Sumner County Sheriff's Department, knew or should have known of these prior incidents and that it failed to protect female inmates. That Sumner County Sheriff's Department failed to enact guidelines and policies to protect the Plaintiff from Defendant Singleton.

### CAUSES OF ACTION

### SEXUAL BATTERY BY DEFENDANT JEREMY MICHAEL SINGLETON

- 21. The Defendant, Jeremy Michael Singleton, owed a duty of care to not harm the inmates. The Defendant, Jeremy Michael Singleton, had a duty to avoid contacting inmates with his genital area and or touching inmates in their genital and private areas. The Defendant, Jeremy Michael Singleton, had a duty to avoid touching inmates in a sexual manner.
- 22. The Defendant, Jeremy Michael Singleton, intentionally violated these duties when he intentionally and forcibly touched the Plaintiff.
- 23. The Defendant, Jeremy Michael Singleton, intentionally violated these duties when he forcibly groped, grabbed, inappropriately touched, and kissed the Plaintiff.
- 24. As a result of these sexual batteries, Plaintiff felt threatened, scared, angry, violated, and humiliated.

### SEXUAL ASSAULT BY DEFENDANT JEREMY MICHAEL SINGLETON

25. The Defendant, Jeremy Michael Singleton, owed a duty of care to not cause an inmate apprehension of the threat of sexual battery and sexual abuse.

- 26. The Defendant, Jeremy Michael Singleton, intentionally violated this duty by inappropriately groping, grabbing, touching, assaulting, and kissing the Defendant. Defendant Singleton also made inappropriate statements and threats to the Plaintiff.
- 27. The Defendant, Jeremy Michael Singleton, intentionally violated this duty by his actions. Plaintiff was scared and humiliated.
- 28. As a result of the sexual assaults by Defendant, Jeremy Michael Singleton, Plaintiff was apprehensive of sexual battery and sexual abuse and Plaintiff felt unsafe.

### INDEPENDENT NEGLIGENCE OF THE SUMNER COUNTY SHERIFF'S DEPARTMENT

- 30. At all relevant times, Sumner County Sheriff's Department operated and / or maintained the Sumner County Jail located at 117 W Smith Street, Gallatin, Sumner County, Tennessee.
- 31. Pursuant to the Tennessee Governmental Tort Liability Act, Tenn. Code Ann. § 29-20-101 et. seq., immunity from suit of Sumner County Sheriff's Department has been removed for injuries resulting from the negligent and intentional actions by Jeremy Michael Singleton, an employee of the Sumner County Sheriff's Department.
- 32. At all relevant times, Jeremy Michael Singleton was an employee, agent, representative, and / or servant of Sumner County Sheriff's Department and was engaged in the course and scope of the employment or agency (real, apparent, or ostensible).
- 33. Sumner County Sheriff's Department has a duty to protect inmates from inappropriate and sexual contact with their deputies, jailors and employees who are in a position of authority.

- 34. Upon information and belief, the sexual abuse of Plaintiff and the injuries of the Plaintiff were proximately, and in fact, caused by one or more of the following acts of the Sumner County Sheriff's Department:
  - A. Sumner County Sheriff's Department negligently hired Defendant, Jeremy Michael Singleton;
  - B. Sumner County Sheriff's Department failed to properly supervise Defendant, Jeremy Michael Singleton;
  - C. Sumner County Sheriff's Department negligently trained Defendant,

    Jeremy Michael Singleton;
  - D. Sumner County Sheriff's Department negligently entrusted Defendant,

    Jeremy Michael Singleton, with the supervision and care of female inmates;
  - E. Sumner County Sheriff's Department negligently failed to follow proper protocols in transporting a female inmate;
  - F. Sumner County Sheriff's Department negligently, carelessly, and / or recklessly continued to retain employee Defendant, Jeremy Michael Singleton, as a jailor with the supervision of female inmates, despite Defendant, Jeremy Michael Singleton, having prior complaints made against him.
  - G. Sumner County negligently allowed male Deputies and or jailors to transport female inmates alone.
- 35. Defendant, Jeremy Michael Singleton's acts of sexual assault and sexual battery of Plaintiff were a foreseeable consequence of Sumner County Sheriff's Department's allowing a male jailor to transport female inmates unsupervised.

- 36. Upon information and belief, Sumner County Sheriff's Department allowed or approved Defendant, Jeremy Michael Singleton, to supervise female inmates without other jailors present. Sumner County Sheriff's Department helped create the dangerous condition that led to injury and damages of Plaintiff by failing to supervise and / or prevent the acts of its agent / employee, Jeremy Michael Singleton.
- 37. Upon information and belief, Sumner County Sheriff's Department allowed or approved Defendant, Jeremy Michael Singleton, to be alone with individual female inmates without other jailors and / or employees present. Sumner County Sheriff's Department helped create the dangerous condition that led to injury and damages of Plaintiff by failing to supervise and / or prevent the acts of its agent / employee, Jeremy Michael Singleton.
- 38. Upon information and belief, Sumner County Sheriff's Department had security cameras and knew or should have known with reasonable diligence of sexual acts performed by Defendant, Jeremy Michael Singleton.
- 39. Upon information and belief, Sumner County Sheriff's Department could foresee, or through the exercise of reasonable diligence, should have foreseen or anticipated, Defendant, Jeremy Michael Singleton's sexual abuse of Plaintiff.
- 40. Defendant, Jeremy Michael Singleton's sexual abuse and the failure of Sumner County Sheriff's Department to properly supervise or prevent its agents / employees from engaging in such acts constitutes negligence by Sumner County Sheriff's Department, by and through its employees, within the meaning of Tenn. Code Ann. § 29-20-205.
- 41. The negligence of Sumner County Sheriff's Department and Jeremy Michael Singleton, as detailed in part in this complaint, proximately caused or contributed to the injuries suffered by Plaintiff.

- 42. For these reasons, Sumner County Sheriff's Department' immunity is removed pursuant to Tenn. Code Ann. § 29-20-205.
- 43. The sexual battery that occurred when Defendant, Jeremy Michael Singleton, groped, grabbed, and inappropriately touched Plaintiff in the County owned transport vehicle is a separate "occurrence or act" within the meaning of Tenn. Code Ann. § 29-20-403.
- 44. The sexual battery that occurred when Defendant, Jeremy Michael Singleton threatened the Plaintiff is a separate "occurrence or act" within the meaning of Tenn. Code Ann. § 29-20-403.
- 45. All other sexual assaults and exploitations that are set forth in this complaint each constitute a separate "occurrence or act" within the meaning of Tenn. Code Ann. § 29-20-403.

### VICARIOUS LIABILITY OF SUMNER COUNTY SHERIFF'S DEPARTMENT

- 46. Under the doctrines of agency and *respondeat superior*, Sumner County Sheriff's Department is vicariously liable for the acts and omissions of its agent / employee, Defendant, Jeremy Michael Singleton.
- 47. Accordingly, Sumner County Sheriff's Department is liable for the damages caused by its agent / employee, Jeremy Michael Singleton.

### HARMS AND LOSSES OF THE PLAINTIFF

- 48. Plaintiff is not at fault for causing the injuries and damages described in this Complaint.
- 49. The Defendants, and each of them, jointly and severally, are 100% at fault for the injuries and damages described in this Complaint.
- 50. As a result of the Defendants' actions, Plaintiff, Amanda Lauren Moore, sustained and continues to suffer from severe emotional and psychological injuries including depression,

anger, isolation, anxiety, suicidal thoughts PTSD, and flashbacks. Plaintiff suffers an all over decrease to her mental well-being due to Defendant, Jeremy Michael Singleton's actions.

- 51. The Defendant, Jeremy Michael Singleton, is liable for the damages he caused by his egregious, offensive, and non-consensual acts against the Plaintiff inmate. Defendant, Jeremy Michael Singleton's actions were done willfully, intentionally, and with full knowledge that his actions were illegal and traumatizing. Defendant, Sumner County Sheriff's Department knew or should have known the Defendant, Jeremy Michael Singleton's propensity for sexual battery and sexual assault of female inmates and failed to take appropriate action to prevent a recurrence.
- 52. As a direct and proximate result of the negligent and intentional acts of the Defendants, Plaintiff, Amanda Lauren Moore, has suffered damages, including, but not limited to:
  - a. Past and future mental anguish;
  - b. Past and future emotional distress;
  - c. Future medical expenses;
  - d. Diminished capacity for enjoyment of life, past and future; and
  - e. Permanent injury.
- 53. As a direct and proximate result, the Plaintiff has suffered intentional infliction of emotional distress and negligent infliction of emotional distress.

### WHEREFORE, PREMISES CONSIDERED, PLAINTIFF DEMANDS:

- 1. That service of process issue and be served upon the Defendants requiring them to appear and answer within the time prescribed by law.
- 2. That judgment be rendered for Plaintiff, Amanda Lauren Moore, and against Defendants, and each of them, jointly and severally, for compensatory damages in a amount to be

determined by a jury in this cause sufficient to adequately compensate the Plaintiff for her damages and losses, but no less than One Million Dollars (\$1,000,000.00).

- 3. For a judgment against Defendant, Jeremy Michael Singleton, holding him liable for punitive damages in an amount to be determined by a jury in this cause sufficient to adequately punish Defendant, Jeremy Michael Singleton, and to deter others from similar reprehensible behavior in this community but no more than Seven Hundred Fifty Thousand Dollars (\$750,000.00).
  - 4. For a jury of twelve (12) to try this cause.
  - 5. For this matter to be taxed to the Defendants.
- 6. For all other relief to which the Plaintiff, Amanda Lauren Moore, may be entitled from this Court including discretionary costs, court costs, post-judgment interest, and any other general relief to which Plaintiff may be entitled.

### How much does an Animal Transport make in Tennessee?

As of Dec 24, 2024, the average hourly pay for the Animal Transport jobs category in Tennessee is \$19.10 an hour.

As far as the table of organization, I would have referred you to those NACA formulas but remember the recommendations for kennels in that reference is strictly cleaning and feeding so in addition to that number, other positions are also needed. There are no specific templates for the table of organization since there is so much variation between each shelter in terms of what programs they provide themselves, outsource or refer to other organizations. I also had to repeatedly correct the misinformation that "We cannot tell the Sheriff's department what to do" and constantly remind everyone of TN state law:

According to Tennessee law, the state legislature controls the animal control code, and counties, through resolutions passed by their respective legislative bodies, are authorized to license and regulate dogs and cats, establish and operate animal shelters, and manage stray animal capture, impoundment, and disposal within their jurisdiction. State Law Authority: The power to regulate animals, including dogs and cats, is outlined in the Tennessee Code Annotated (TCA), which is controlled by the state legislature.

In other words, Animal Control is controlled by the County Commissioners.

Yes, under our TN state Constitution, the citizens have the right to instruct elected officials, accordingly.

Who would ever want to fund abuse to inmates and barriers to adopting animals during <u>all hours of operation</u> that results in euthanizing animals when new intakes come in and there's no more room?

For the record, I questioned where the job positions were posted. They were only posted on the Sheriff's website, not on Monster, Indeed, or any other viable job search engine for greater outreach.

We were informed about a myriad of roadblocks and long delays in filling these job openings due to the use of inmates.

Also, when I visited Animal Control with my friend Marlis a few months ago, we noted that the inmates were not supervised and Lt. Tarlacky was the only male transporting 4 female inmates alone in the van.

Clearly, nothing changed, when changes should have been made immediately, instead of Sumner continually operating on willful blindness.

In light of the these insights and recent disturbing developments, I reached out thinking that your organization would know, based on the size of our county, population, number of intakes, and other variables, how to provide guidance specifically on a best practice model with an animal control director reporting to the mayor, staff to care for the animals, volunteers to assist in adoptions or moving animals to rescues working in partnership with our Animal Care Facility, etc.

At baseline, and from a common sense perspective, if we do not have a best practice model in place and continue to keep a badly broken status quo, how can we ever expect to achieve best practice goals?

It's futile.

Nonetheless, I did a quick search and found a primary acceptable source to use as a guideline in building an optimal Animal Care infrastructure that I'm passin that hopefully assists for future reference.

I will use these data and methodology as a way to provide an approximate optimal staffing model for our County Commissioners to review for consideration, especially in light of the troubling developments mentioned above.



# U.S. prison labor programs violate fundamental human rights, new report finds

Jun 16, 2022

Law School's Global Human Rights Clinic, ACLU examine coercion, exploitation in prison labor

Incarcerated workers generate billions of dollars worth of goods and services annually but are paid pennies per hour without proper training or opportunity to build skills for careers after release, according to a comprehensive nationwide report released by the University of Chicago Law School's Global Human Rights Clinic

(https://www.law.uchicago.edu/ghrc) and the American Civil Liberties Union.

The first-of-its-kind report, <u>Captive Labor: Exploitation of Incarcerated Workers</u> (https://www.aclu.org/report/captive-labor-exploitation-incarceratedworkers), examines the use of prison labor throughout the U.S. and highlights how incarcerated workers' labor helps maintain prisons and provides vital public services. <u>Captive Labor</u> also calls for far-reaching reforms to ensure prison labor is truly voluntary and that incarcerated workers are paid fairly, properly trained, and able to gain transferable skills.

"As our report describes in detail, the labor conditions of incarcerated workers in many U.S. prisons violate the most fundamental human rights to life and dignity," said Clinical Prof. Claudia Flores, the director of the Global Human Rights Clinic. "In any other workplace, these conditions would be shocking and plainly unlawful. The many incarcerated workers we interviewed told us story after story of inadequate equipment and training, punishments doled out if workers refused to labor, and an overall helplessness to a government institution functioning as both jailer and boss."

### Key findings include:

- Nearly two-thirds (65% percent) of incarcerated people report working behind bars—amounting to roughly 800,000 workers incarcerated in prisons.
- More than three quarters of incarcerated people surveyed (76%) report facing punishment—such as solitary confinement, denial of sentence reductions, or loss of family visitation—if they decline to work.
- Prison laborers are at the mercy of their employers. They have no control over their work assignments, are excluded from minimum wage and overtime protections, are unable to unionize, do not receive adequate training and equipment, and are denied workplace safety guarantees despite often dangerous working conditions.
- As a result, 64% of incarcerated workers surveyed report worrying about their safety while working; 70% percent say they received no formal job training; and 70% percent report not being able to afford basic necessities like soap and phone calls with prison labor wages.
- Incarcerated workers produce at least \$2 billion in goods and \$9 billion worth of prison maintenance services annually, but this number is not closely tracked and is likely much higher.
- Yet, most states pay incarcerated workers pennies per hour for their work. Seven states (Alabama, Arkansas, Florida, Georgia, Mississippi, South Carolina, and Texas) pay nothing for the vast majority of prison work. Other states pay on average between 15 and 52 cents per hour for

- non-industry jobs. Prison laborers often see up to 80% of their paycheck withheld for taxes, "room and board" expenses, and court costs.
- More than 80% percent of prison laborers do general prison
  maintenance, which subsidizes the cost of our bloated prison system.
  Other tasks represent less than 10% percent of work assignments,
  including: public works projects (like road repair, natural disaster
  assistance, forestry work, and maintenance of parks, schools, and
  government offices); state prison industries, agricultural work, and
  coveted private company work assignments.

"The United States has a long, problematic history of using incarcerated workers as a source of cheap labor and to subsidize the costs of our bloated prison system," said Jennifer Turner, principal human rights researcher with the ACLU's Human Rights Program. "Incarcerated workers are stripped of even the most minimal protections against labor exploitation and abuse. They are paid pennies for their work even as they produce billions of dollars for states and the federal government. It's past time we treat incarcerated workers with dignity. If states and the federal government can afford to incarcerate 1.2 million people, they can afford to pay them fairly for their work."

The exploitation of incarcerated workers is rooted in the "exception clause" to the 13th Amendment, which bars slavery except for people who have been convicted of crimes. In many states—and in the United States Constitution—exception clauses allow for workers in prisons to be exploited, underpaid, and excluded from workplace safety protection laws. Worse, the exception clause in the 13th Amendment disproportionately encouraged the criminalization and re-enslavement of Black people during the Jim Crow era, and we still feel the impacts of this systemic racism to this day in the disproportionate incarceration of Black and Brown community members.

To combat the exploitation of incarcerated workers, the report makes several recommendations, including:

- Ensure that all work in prisons is fully voluntary by eliminating any laws and policies that punish incarcerated people who are unable or unwilling to work.
- Allow incarcerated workers the same labor protections afforded to other workers in the United States, including minimum wage, health and safety standards, unionization, protection from discrimination, and speedy access to redress when their rights are violated.
- Institute comprehensive safety and training programs for all work assignments in correctional institutions.
- Invest in prison work programs that provide incarcerated workers with marketable skills and training that will help them to find employment after release and eliminate barriers to employment after release.
- Amend the US Constitution to abolish the 13th Amendment's exclusion that allows slavery and involuntary servitude as punishment for a crime.

Captive Labor: Exploitation of Incarcerated Workers comes more than two years into the COVID-19 pandemic, during which incarcerated workers faced especially brutal working conditions and yet were denied early access to vaccines in 16 states. Incarcerated people were forced to produce masks, hand sanitizer, and other personal protective equipment. Others were forced to launder bed sheets and gowns from hospitals treating COVID patients, transport bodies, and dig graves. Many report being forced to continue working but not able to have visitors and having their parole date pushed back if they refuse to work. More than a third of incarcerated people have contracted COVID-19 since the pandemic started and more than 3,000 have died.

"The U.S. prison system claims to offer rehabilitation to its population, but prison labor programs do just the opposite: they degrade, dehumanize and further cripple incarcerated workers," said Mariana Olaizola Rosenblat, a UChicago lecturer in law and fellow at the Global Human Rights Clinic. "The many incarcerated workers we interviewed voiced a strong desire to engage productively in society under dignified conditions. It's time for the U.S. government and prison authorities to give them this chance, not merely rhetorically but in practice."

The Law School's Global Human Rights Clinic partners with human rights and civil rights organizations around the world to conduct investigations, develop strategies, and advocate for human rights before international, national, and local decision makers and stakeholders.

The *Captive Labor* report reflects the work of three generations of GHRC students, faculty and staff. From 2018 to 2022, the clinic team conducted extensive research and completed drafting of a report highlighting the violations of the human rights of incarcerated workers in the United States. They analyzed state and federal laws, policies, and practices that result in these violations of international human rights standards, and detailed the multiple exploitative aspects of prison labor as recounted by incarcerated workers themselves. The clinic also provided a set of recommendations for federal, state and local governments, state departments of corrections, the Federal Bureau of Prisons, correctional authorities, and private companies involved in prison labor.

In addition to contributing to the drafting and research of the report, the clinic filed FOIA requests in 50 states, surveyed more than 100 workers currently behind bars in three states (Illinois, Louisiana and California), completed a fact-finding trip to Louisiana in March 2020, and conducted 65 interviews with key stakeholders including experts, formerly incarcerated individuals, representatives of advocacy organizations, academics, and leaders of reentry organizations across the country.

### Tennessee Constitutional Amendment 3

On November 8, 2022, Tennessee voters approved Amendment 3, which amended Article I, Section 33 of the Tennessee Constitution. The amendment:

- Removed language that allowed slavery and involuntary servitude as criminal punishments
- Added the statement, "Slavery and involuntary servitude are forever prohibited in this state"
- Added the exception, "Except as punishment for a person who has been duly convicted of crime"

### Effect on prison labor

The amendment could make involuntary offender labor unlawful. However, the Tennessee Department of Correction (TDOC) requested that the amendment include language that would not prevent incarcerated people from working.

### Comparison to the 13th Amendment

The 13th Amendment to the United States Constitution also prohibits slavery and involuntary servitude, except as punishment for crime.

### Barriers to adoption

When transporting an inmate, a correctional officer is at a heightened risk of danger due to the unpredictable nature of the situation, requiring constant vigilance and consideration of potential threats from the inmate, external parties, or even the environment itself, making it a highly vulnerable position with many factors to monitor and manage. Key points about the vulnerability of transporting an inmate:

### Potential for escape attempts:

An inmate might try to flee during transport, especially if they see an opportunity due to a lapse in security or a distraction.

### Risk of assault:

Inmates may become aggressive or violent towards the officer during transport.

### Contraband concerns:

The officer needs to be aware of the possibility of the inmate concealing contraband on their person or attempting to smuggle it into the vehicle.

### External threats:

Individuals associated with the inmate might try to intervene during transport to facilitate an escape or harm the officer.

### Limited control:

Once in the transport vehicle, the officer has limited ability to react to sudden changes or dangerous situations.

What officers need to consider during transport:

### Inmate behavior:

Continuously monitoring the inmate's actions and body language to identify potential threats.

### Security measures:

Ensuring proper restraints are applied and the vehicle is secured.

### Route planning:

Selecting safe and well-traveled routes with contingency plans for unexpected situations.

### Communication:

Maintaining clear communication with dispatch and other officers regarding the transport status.

### Search procedures:

Thoroughly searching the inmate and transport vehicle before and after transport to prevent contraband.

You are very vulnerable when you are transporting an inmate. There is a lot to think about.

Your department probably transports inmates outside of your jail several times a day without incident.

But, because it happens so frequently, it's easy for complacency to set in. "I've done it a hundred times. We've never had a problem." This <u>complacency</u> can turn a routine transport into a disaster.

You are very vulnerable when you are transporting an inmate. There is a lot to think about.

You should always be concerned with contraband during transport. You should be following your department's policy. Search the transport vehicle and the inmate before and after the transport.

You should make a comprehensive transport plan.

Include primary routes and alternate routes.

Decide in advance how the inmate will be restrained.

Limit communication with the inmate about the transport. Does the inmate know where they are going? Or when? Have they had access to a telephone in the housing unit?

Who outside the facility knows about the transport? Make contingency plans. What will you do if you get into an accident? Or if you get a flat tire?

Consider external threats as well. There may be someone seeking the opportunity to intervene on your transport to harm your inmate or to launch an escape attempt.

No matter how many times they have gone off without a hitch, remember that <u>transports are high-risk activities</u>. It's important to actively resist complacency.

Remain vigilant. Plan and prepare. Things could go wrong when you least expect it.

### To reduce the risk of transporting inmates, agencies can:

### Use specially-designed vehicles

These vehicles are modified to make it harder for inmates to escape, such as by removing window cranks and door handles from the rear compartment.

### Use technology

Vehicles can be equipped with cameras, microphones, and speakers to allow officers to monitor and communicate with inmates.

### · Take extra security measures

This can include additional restraints, more secure vehicles, and escorts from additional law enforcement agents.

### • Start transports at night

This can help minimize the chance of harm to civilians.

### Select and train officers carefully

Officers should be properly selected and trained for the risks of transporting inmates.

### Plan and prepare

Transports are high-risk activities, so it's important to remain vigilant and plan and prepare.

Inmates are classified as high risk, high value, or high profile based on their charges, history, and affiliations.

### Definition

 Unwelcome verbal, visual, or physical conduct of a sexual nature that is severe or pervasive and affects working conditions or creates a hostile work environment.

### Breaking down the definition : "Conduct"

 Conduct is NOT sexual harassment if it is welcome. For this reason, it is important to communicate (either verbally or in writing) to the harasser that the conduct makes you uncomfortable and you want it to stop.

### "Of a Sexual Nature"

- Verbal/Written: Comments about clothing, personal behavior, or a person's body; sexual or sex-based jokes; requesting sexual favors or repeatedly asking a person out; sexual innuendoes; telling numors about a person's personal or sexual life; threatening a person, sending emails or text messages of a sexual nature.

- For example, it may be sexual harassment if you are a woman working as a carpenter on an all-male job, and you are the only one whose tools are frequently hidden by your male co-workers.

Equal Rights Adocates

### "Severe or Pervasive"

- The conduct of the harasser must be either severe or pervasive to be classified as sexual harassment.
- Although a single unwanted request for a date or one sexually suggestive comment might offend you and/or be inappropriate, it may not be sexual harassment. However, a number of relatively minor separate incidents may add up to sexual harassment if the incidents affect your work environment.

Equal Rights Adocates

### Questions to ask yourself:



- How many times did the incidents occur?
- How long has the harassment been going on?
- How many others have been sexually harassed?
- Who were witnesses to the harassment?

### "Affects working conditions or creates a hostile work environment"

- It may be sexual harassment if the conduct unreasonably interferes with your work performance or creates an "intimidating, hostile, or offensive work environment."
- For example, it may be sexual harassment if repeated sexual comments make you so uncomfortable at work that your performance suffers or you decline professional opportunities because it will put you in contact with the harasser.

### Types of Sexual Harassment

 Quid Pro Quo ("This for that")

- Transmitting or posting emails, texts, or pictures of a sexual or other harassmentrelated nature.
- Displaying sexually suggestive objects, pictures, or posters.
- Playing sexually suggestive music.



### Filing a Complaint

If an individual believes that Sumner County Jail's Harassment Policy has been violated, the person must report the incident to the Sheriff, the Jail Administrator, the Assistant Jail Administrator or the County Executive. The information surrounding the incident will be kept as confidential as possible. An investigation will be promptly made and the complaining individual will be advised of the results of the investigation and of the action Sumner County Jail takes with respect to the complaint. If the offending person is an employee, discipline, up to and including termination, may be imposed.



### Job Descriptions Below:

### Lieutenant/Sergeant

May be required to be P.O.S.T. or T.C.I. certified, depending on the assignment. The immediate supervisor of employees under his/her command. Ensures policies and procedures are followed and to notify his/her immediate supervisor of situations or circumstances of concern. May be responsible for scheduling subordinates' work hours and submitting accurate timesheet information. Depending on assignment, the Lieutenant/Sergeant may be responsible for obeying and enforcing the laws of Sumner County, the State of Tennessee, and the United States of America. All other like duties as assigned.

### Deputy

Required to be P.O.S.T. certified as prescribed by law. Responsible for responding to and investigating routine calls for service. Performs and/or assists with criminal investigations, presenting evidence, and interviewing victims and witnesses. Responsible for maintaining duty certification and keeping abreast of current laws, rules, regulations, and policies. Responsible for obeying and enforcing the laws of Sumner County, the state of Tennessee, and the United States of America. Must possess a valid Tennessee operator's license. All other like duties as assigned. Deputies are responsible for serving criminal warrants.

### Clerical

General duties may include but are not limited to reports, filing, telecommunications, correspondence, computer input and retrieval, and general office duties. All other like duties as assigned. Required to keep safe and maintain the official records of the Sumner County Sheriff's Office. Required to receive and maintain certifications associated with the position (such as T.I.B.R.S. or T.O.M.I.S.). All other like duties as assigned.

### **All Employees**

Responsible for following all Sheriff's Office, Sumner County, State of Tennessee, and United States of America laws, rules, regulations, policies, and applicable procedures. Maintain professional attitude, appearance, and demeanor while discharging their duties. Note: DTF, K-9, SWAT, DIVERS, SRO, FTO, Dare, Firearms Instructors, Negotiators, and other similar assignments are voluntary assignments subject to appointment by the Sheriff. The Sheriff may remove an employee from any specialized assignment at any time.

All employees, regardless of assignment, must exhibit specific physical attributes to provide adequate service to the citizens of Sumner County.

Vocal communication is required for conveying detailed or important instructions to others accurately, loudly, or quickly; hearing is required to receive detailed information through oral communications and/or to make fine distinctions in sound; and visual acuity is required for night vision, peripheral vision, preparing and analyzing written computer data, and visual inspection involving small defects and/or small parts. Must possess a valid Tennessee operator's license. Required to work indoors and outdoors with the possibility of exposure to adverse weather conditions and hazardous or extremely dangerous situations.

Other physical requirements include: this job may require lifting objects that exceed 50

lbs., with frequent lifting and/or carrying of objects weighing up to 25 lbs. Other physical demands that may be required are as follows:

## MINUTES LEGISLATIVE COMMITTEE JEREMY MANSFIELD, CHAIRMAN JANUARY 13, 2025

Chairman Mansfield brought the regular scheduled Legislative Committee meeting to order with an invocation by Commission Chairman Hyde on Monday, January 13, at 5:30 p.m. Chairman Mansfield declared a quorum present to conduct business.

#### 3. Approval of Agenda.

Comm. Miller moved, seconded by Comm. Jones, to approve the agenda as amended. The motion carried unanimously.

#### 4. Approval of minutes of December 9, 2024.

Upon motion of Comm. Miller, seconded by Chairman Mansfield, the Committee voted to approve the minutes of December 9, 2024. Comm. Shoaf abstained from the vote.

#### 5. Recognition of the Public.

Kevin Baigert of 424 AB Wade Road, Portland spoke in favor of the proposal for the location of the Election Commission and applauded Comm. Klein on his work.

Barry Cleveland of 1680 Foxland Blvd, Gallatin did not speak

#### 6. Report of the Chairman.

No report

No report

#### 8. Old Business.

#### a. Discussion - Constables.

Chairman Mansfield explained the Constables were abolished by a previous Commission in 2012.

Comm. Jones moved, seconded by Comm. Miller, to discuss. The motion carried unanimously.

Law Director Eric Sitler further explained that the statute does not allow for reinstatement.

Comm. Shoaf moved, seconded by Commission Chairman Hyde, to strike from the agenda. No action needed.

Commission Chairman Hyde stated he was contacted by CTAS representative who explained once abolished forever abolished.

Removed from old business.

### b. <u>Discussion: Property Assessor's Appraisals and Election Boundary</u> Concerns.

Chairman Mansfield moved, seconded by Comm. Miller, to suspend the rules to allow Comm. Rogers to speak to the matter. The motion carried unanimously.

Comm. Rogers explained there was an error in the system for the calculation of his father's property taxes which resulted in an approximately \$600.00 increase even though he has a tax freeze. He further explained state law allows the dwelling plus five acres for the freeze. A tax notice was never received. He then asked County Mayor John Isbell how to handle the situation and Mr. Isbell recommended Comm. Rogers file an appeal with the State Board of Equalization.

Tax Assessor John Hurt explained data was not given by Patriot when the system change occurred. His understanding is Patriot wants a fee to release the data.

Comm. Rogers reached out to the comptroller and CTAS and asked how many parcels with over 5 acres were frozen and land units that were frozen. He is also concerned is there is a surplus or shortfall in the county budget. He also questioned how the Tax Assessor can levy taxes. He also questioned how as the county legislative body is it made right to the citizens.

He also explained that the election boundary set by the City of Portland is wrongly set for the parcel. The parcel is also split into county commission district two and district five. The whole parcel should be county commission district five. The Election Commission stated they use the maps and boundaries provided by the cities. He is still in talks with City of Portland about the incorrect city limit boundary.

Comm. Becker asked how much Patriot wanted to charge for the data. Mr. Hurt stated he was not involved in the talks at the time of transition but believes it was around \$50,000 or \$60,000 per year to view the data. Comm. Jones asked Mr. Hurt to get the details on obtaining the data from Patriot.

Chairman Mansfield brought the meeting back in session.

Comm. Shoaf asked for a course of action to be presented next month. Chairman Mansfield asked Mr. Sitler to work with Finance and Mr. Hurt to review the contract with Patriot. He also asked Mr. Hurt to contact Patriot to ask if they still have the data and how much it would cost to purchase.

During further discussion, Mr. Isbell explained property tax is calculated outside of the system no matter what system is used. He stated the only thing drawn from the system is value and only changes at reappraisal. His understanding is there was a land merge that increased the value, and no one caught the increase in acreage and the tax freeze continued on the entire property.

Law Director Eric Sitler explained the coordinator is needed for grants and to remain in compliance of Title VI.

Chairman Mansfield moved. Seconded by Comm. Shoaf, for the position to reside in the law office.

Comm. Shoaf moved, seconded by Comm. Becker, to amend to appoint Law Director or his designee within his office. The motion carried unanimously.

Chairman Mansfield moved, seconded by Comm. Shoaf, to reconsider. The motion carried unanimously.
