The Board of County Commissioners of Sumner County, Tennessee met in regular session on September 15, 2025, in the Commission Chambers of the Sumner County Administration Building in Gallatin, Tennessee at 7:02 p.m. Present and presiding was the Chairman Jerry Becker. - **WHEREAS**, it is with great pride and deep appreciation that this body recognizes those individuals who have dedicated their lives to public service, upholding justice, and protecting the people of Tennessee; and
- **WHEREAS**, Ray Whitley, born on March 11, 1944, in Ripley, Tennessee, has devoted more than five decades to the practice of law and over forty-five years to serving as the District Attorney General for the 18th Judicial District, representing Sumner County with integrity, fairness, and an unwavering commitment to justice; and
- **WHEREAS**, General Whitley graduated from Ripley High School in 1962, earned his Bachelor of Arts and Science degree in English and History from Louisiana State University in 1966, and his Juris Doctor from Memphis State University Law School in 1969; and
- **WHEREAS**, General Whitley honorably served his country as a Captain in the United States Army and is a proud Vietnam Veteran, demonstrating leadership and courage both abroad and at home; and
- WHEREAS, his distinguished legal career includes serving as an Assistant United States Attorney in Nashville from 1971 to 1977, Assistant District Attorney in Sumner County from 1978 to 1980, and since 1980, as the elected District Attorney General for the 18th Judicial District, having been reelected by the citizens of Sumner County six times, most recently in 2022; and
- **WHEREAS**, General Whitley's record-setting 45-year tenure as District Attorney General is the longest in Tennessee history, during which time he has overseen countless cases with diligence and fairness, advanced the cause of justice, and worked to ensure safer communities for the citizens he faithfully served; and
- **WHEREAS**, his leadership extended beyond the courtroom, having served as President of the Tennessee District Attorneys General Conference on three separate occasions (1985–1986, 2006–2007, and 2023–2024), reflecting the great respect and admiration he earned from his peers across the state; and
- WHEREAS, throughout his career, General Whitley has been recognized for his exemplary service, receiving the prestigious McCutchen Award in 2008 from the Tennessee District Attorneys General Conference for his devotion to duty and commitment to justice, and the Lifetime Achievement Award from the Gallatin Police Department in 2023; and
- **WHEREAS**, among his many accomplishments, General Whitley's office has collected more than \$370 million in child support payments for the children of Sumner County, leaving a lasting impact on families and future generations; and
- **WHEREAS**, General Whitley has also been a leader in his community as a member of First United Methodist Church of Hendersonville and Past President of the Gallatin Lions Club; and
- **WHEREAS**, his life has been further blessed through his marriage to his wife, Pat, their four children, and eight beloved grandchildren; and
- **WHEREAS**, Ray Whitley's extraordinary career as District Attorney General, his record of faithful service to his country, state, and community, and

his legacy of leadership, justice, and integrity will long be remembered and celebrated.

**NOW, THEREFORE, BE IT RESOLVED** by the Sumner County Board of County Commissioners meeting in regular session on this the 15<sup>th</sup> day of September, 2025, that we hereby recognize and honor Ray Whitley on the occasion of his retirement, commend his outstanding service as District Attorney General for the 18th Judicial District, and extend to him and his family our gratitude, respect, and best wishes for the years to come; and

#### RECOGNITION OF THE PUBLIC

Chairman Becker opened the floor to allow the public to speak concerning any matter on the agenda.

Brad Williams of 1916 Hwy. 31W, White House, addressed the fire tax referendum and funding options for volunteer fire departments. He spoke against utility districts and subscription-based services and expressed support for forming an ad hoc committee to develop a fire tax plan.

Charlena Aumiller of 143 Ruland Circle, Hendersonville, questioned the need for an interim Finance Director since the current director remains until October 31, 2025. Citing the 2012 Financial Management Act, she supported the assistant taking over when the position is vacated. She also backed the volunteer fire distributions but questioned the need for two publications and agreed a plan should precede any fire tax referendum.

Mike McClard of 102 Tioga Trail, Hendersonville, expressed his support for funding the volunteer fire departments but uncertain about a fire tax.

Wayne Drown of 1120 N. Corinth Road, Portland, spoke to the volunteer fire department items and the need to move forward with more funding. He also supports a fire tax but a plan is needed.

Curtis Williams of 1027 Jackson Heights Road, spoke to the volunteer fire departments funding. He reported 75 counties in the state work from non-profit donations while 7 use fire tax funding. He stated a plan is needed for a fire tax referendum and supports an ad hoc committee.

With no one else wishing to speak on regular agenda items or budget items, recognition of the public was closed.
